The meeting was opened with the flag salute.

MOMENT OF SILENCE / MARGARET FETTES AND ORLANDO TRAGEDY

Supervisor Tompkins asked for a moment of silence for former County Legislator Margaret Fettes who passed away this month and for the victims of the Orlando, Florida shootings.

William McCabe spoke about the many services that Margaret Fettes had performed for Dutchess County and the Town of Union Vale.

Elfriede Tillman also spoke regarding Mrs. Fettes' many contributions to the Town and the Union Vale Fire Company.

Damar Osika spoke about Mrs. Fettes contributions and also she was a cancer survivor and involved the Cancer Society Relay for Life.

OPEN MEETING TO PUBLIC COMMENT ON AGENDA ITEMS ONLY

There were no comments on agenda items and the regular order of business was begun.

SUPERVISOR REPORT

Supervisor Tompkins mentioned that Community Day was successful and she thanked the Councilmen John Welsh, Steve Frazier, David McMorris and Rob Mattes for joining her in going in the dunk tank. Ms. Tompkins also thanked everyone who contributed to the fireworks display. There is an opening on the County Transit Development Plan Advisory Committee and Peter Bonk has submitted an application. Time clocks are being purchased for the Town Hall the park and highway department. Requests for Proposals are being published for Town Planner and Town Engineer.

Councilman Frazier stated that the detour on Route 55 for the bridge re-construction is a failure and is causing traffic problems. The State Troopers and Deputy Sherriff are there writing tickets.

Councilman Frazier offered a motion that a formal complaint regarding these traffic problems be sent to the State on town stationary. The motion was seconded by Councilman Welsh and passed unanimously.

Councilwoman Kelley mentioned that the Town has a number that residents can call with problems regarding this bridge reconstruction.

Councilman Welsh mentioned that he will be talking with the grant writer regarding shared services and also regarding funding for revamping the salt shed at the highway garage.

HIGHWAY REPORT

Mr. Wisseman reported that the men have added material, graded and rolled the dirt roads. They spread calcium chloride on the dirt roads for dust control. The men spread about 40 tons by hand. They patched Oswego Road and Mallory Road, spread 70 tons by hand and rolled it. Cleaned and re stoned the ditch at Oswego and Cole Roads. Roads that were patched so far are: North and South Parliman Roads; Mennella Road; Still and Pleasant Ridge Extension, Walsh Road, West Clove Mountain Road and Jennifer Hill. The inside turns on Wisseman Road were touched up. Replaced some signs. Mowed one pass around the whole town, both sides of the road where needed. Boom mowed brush and tree limbs that were encroaching into the road. Repaired some drainage at 273 Barmore Road. Repaired drainage and two catch basins on Darren Road. Did drainage work at 20 Walsh Road. Fixed a black top curb and swale in Cooper Drive. Picked up a couple bags of garbage that town residents had filled from road side clean up. Thank you to the

Foley family and John and Loretta Ryan. Caught several code violations and reported them to George Kolb. Replaced the muffler on truck 3. Ordered the big pipe for Meadow ridge. The arch pipe that is being donated to us from the Town of Poughkeepsie will be disassembled into three pieces next week. We will move it to the town garage after that.

CODE ENFORCEMENT OFFICE REPORT

George Kolb submitted a report showing 33 Building Permits issued, 62 Inspections performed, 7 complaints received and 5 acted on, 19 hours spent on plan reviews, 0 Fire Call Out, 4 Violation Notices issued, 3 Violations abated, 0 Appearance Tickets issued, 26 Certificates of Occupancy and Certificates of Compliance issued, 11 applicant meetings, 8 Municipal Searches issued and 15 old permits were closed for May.

TAX COLLECTOR

Edna Bonk, Tax Collector reported collecting \$147,414.55 for the month of May. \$255,259.10 was paid to Dutchess County and \$5,613.10 in penalties and \$88.00 in postage was turned in to the Supervisor. Unpaid tax bills were returned to the Dutchess County Commissioner of Finance on June 9, 2016. Any unpaid taxes must be paid to the County, no more tax payments accepted by the Town.

Councilman Frazier asked the Town Attorney Thomas Jacobellis for his opinion this matter. Mr. Jacobellis stated that he doesn't feel that the policy and application need to match verbatim.
