Vice-Chairman Fleshman wanted to ask about Trustee Ralph Horn's supplemental insurance because he wants to keep his current health insurance he wanted to see if the Township could cover the cost of his supplemental insurance. The attorney said that he feels the Township needs to check on this with the Auditor. Lisa said she would check on this.
