A NEW AMBULANCE IS IN SERVICE

In the Spring we welcomed Engine 11 to our station, although only being in-service for six months, it has proven itself on numerous emergency calls.



Not to be overshadowed by a new engine, we welcome another new vehicle to our fleet. Medic 11-3 has arrived and will be serving the community by the time you read this. This unit is now one of two 4x4 all-weather advanced life support units ready to respond when the calls come. This unit contains the newest features required by the Office of EMS; they include an enhanced patient safety system used during transport, an upgraded cot loading system for patient and provider safety and a climate controlled medical supply cabinet to insure the quality of over two dozen medications carried for pre-hospital care.

Donations from the community and a grant from the Virginia Department of Health's Virginia Rescue Squad Assistance fund made this \$211,000.00 purchase possible.

Every Second Counts: Plan 2 Ways Out!

In a fire, seconds count. Seconds can mean the difference between residents of our community escaping safely from a fire or having their lives end in tragedy. That's why this year's Fire Prevention Week theme: "Every Second Counts: Plan 2 Ways Out!" is so important. It reinforces why everyone needs to have an escape plan.

Here's this year's key campaign messages:

- Draw a map of your home sharing it with all members of your household, marking two exits from each room and a path to the outside from each exit to your safe meeting place.
- Practice your home fire drill at least twice a year.
- Conduct one at night and one during the day with everyone in your home, and practice using different ways out.
- Teach children how to escape on their own in case you can't help them.
- Make sure the number of your home is clearly marked and easy for the fire department to find.
- Close doors behind you as you leave – this may slow the spread of smoke, heat, and fire.
- Once you are outside, stay outside. Never go back into a burning building!

FIRE SAFETY REMINDER

Every year we remind everyone to test your smoke detectors and replace the batteries as needed. This is an important step in your overall winter safety. You are at greater risk in the winter season when cooking holiday meals, displaying decorations and combating the cold with the use of potentially unsafe heat sources. You can help prevent winter related fires in your home by being diligent when it comes to the safety of your family, friends and neighbors. Never overload outlets or power strips, follow all instructions and warnings on decorations and extension cords. You may have an unsafe heat source and not know it; have furnaces and flues inspected by qualified personnel. Keep young children away from space heaters and only operate them as permitted by the manufacturer's instructions. We all know the rights and wrongs when it comes to candle and warmer safety. Please check and double check that candles are out and warmers off before leaving home or going to bed. Never leave them unattended. The threat of winter fires is real; 905 people die in winter home fires yearly. \$2,091,000,000 in property loss occurs from winter home fires. 67 percent of winter fires occur in one- and two-family homes. Cooking is the leading cause of all winter home fires. 5 to 8 p.m. is the most common time for winter home fires. Only with your help will statistics like these go down!

Your first due fire company is based on the response time from the closest station not your zip code. Why wouldn't you want that for your safety and protection? If you are receiving the newsletter, you live in the Stephens City first due area. We do not blanket mail all zip codes or send out a saturation fundraising form from a third-party vendor. OUR ANCILLARY BUILDING IS BEING COMPLETED!



The anticipated completion of the ancillary building is in sight. Now that it is under roof, the floor and apron will be poured this month. This project adds an additional 4250 sq. ft. of storage to the facility and will be used to store a Technical Rescue Squad, Fire Engine, three rescue boats, a utility truck, a support trailer, grounds maintenance equipment and other support items for emergency services. The goal is to have the building fully operational by winter.
