#### **GROUP AUTONOMY**

Some may think that we have carried the principle of group autonomy to extremes. For example, in its original "long form," Tradition Four declares: "Any two or three gathered together for sobriety may call themselves an A.A. group, provided that as a group they have no other affiliation."\*... #### Many Ways to Do It

# A member shares his experience with concept of autonomy

When I was drinking, I had this idea that the word "autonomous" meant something like proud, isolated and alone. I considered *myself* autonomous and I had this picture of myself outside the crowd, someone who everyone was maybe frightened of but definitely impressed by.

Meanwhile, I was passing out in crowded places and, upon waking up, trying to figure out how to get out before anyone found out I had wet the furniture I passed out on. There were times I had to be helped up before I choked on my own vomit. I was isolated, yes, and as alone as I could get, and a lot of the time I was treated like a threat to myself because I was.

When I came to A.A., I hoped I was wrong about what autonomous meant, just like I'd been wrong about everything else. And thank God, I was.

The definition of the world autonomous that jumps out at me right now is "not subject to control from the outside." That definition fit the AA members I met even before I came into the program. They were free, in the sense of not being in trouble with someone like I always was. They carried their freedom on the inside while functioning as happy, responsible people in society. I could see that freedom in their eyes.

At my first home group-the Here's H.O.W. group in Carbondale Illinois- the autonomy there hit me beautifully. Nobody monitored our meeting to see if we were doing things right. Nobody treated our meeting like a personal AA franchise, checking to that we displayed the logo prominently. Nobody shared reports about our meetings with the "home office." Our group didn't look anything like any organization I'd ever tried to join. Again, the freedom I saw in the people there touched me. A sense of peace came into me when I walked into our meeting room.

Since those very early days-thank to the Third Step-a lot of great life changes have taken me to many different places and different places and different AA meetings. And Tradition Four has helped me tremendously along the way to do what an old-timer friend once suggested: Be open to how people at a new meeting are staying sober. That "committee" that lives up in my head will often start making a list of things "they" are doing "wrong". But then, as the meeting goes on, I slowly become one of the "we" and those delightful differences helped me see what we all share. I get to experience the same thing, no matter where I go to meetingsalcoholism, and sobriety through the Twelve Steps.

Recently, I counted up all the AA meetings I've gotten to attend. I believe I've been to meeting in 22 states in the U.S. and four different countries. Throughout my travels, I've kept on getting this gift that I could never give myself: and open mind.

It's because the Twelve Steps give me an open heart.

Maybe I have gotten more autonomy because of all those different meetings I've been able to attend, along with the grace to accept other people's autonomy. Caring without controlling, that's what I've been shown at all those meetings, in one way or another. That's something I can share at my current home group, at other meetings and outside of them too.

### GIFT OF SERVING AS THE PI/CPC REPRESENTIVE

I have held a number of service positions since getting sober. I started off as the coffee maker for Cullen Mall group in Corpus, spent a couple of years on the committee for the Jamboree, then secretary for the River Group, CSOR and Alt GSR for Women's Solutions Group, and a few short service opportunities helping with raffles, workshops, and that sort of thing. I took the PI/CPC position in January and honestly have never heard of this position until a couple of years ago. For me, the reward of this service position in particular, is reinforcing the identity AA gave me through the steps and applying these principles to all areas of my life. I would never have been able to interact with the professional community as the person I was before this miracle happened. Judges, professionals, these people I still consider intimidating sometimes were completely unapproachable in the past. Today having

this put in front of me (we can't say no?) reminds me that I am not any less than or more than anyone else. I get to be a part of and that is a real miracle to be able to put on this skin and wear it like a loose fitting garment in a whole new crowd. What a gift that is!!

I also have never been able to participate in the service organization in AA without feeling truly overwhelmed by the inspired structure of our organization and how it continues to hold the responsibility statement at the forefront to guide all of our decisions and actions from the groups directions. I have met many members who have given their own time, money, and efforts for no other reason than to help AA thrive and reach people whenever they need it. Without the infrastructure provided by these volunteers, AA would be so fragmented and out of touch, our message and program would be any kind of variation the locals thought up, and the person who just hit bottom might have a very hard time figuring out where to go for help. I feel like I am crashing the party with these folks most days but I learn so much from them and am so grateful to have the opportunity to learn about the service structure of AA and participate in helping to keep it going. If you don't love being sober and this program (or just want to more), I suggest taking a service position. It connects me more to others than anything else I do in sobriety because I don't get to just stay in the company of people it's easy to be in the company of, if that makes sense. I usually learn the most from the people I wouldn't normally gravitate to and that's a beautiful thing.
