A Government Gone Berserk

Hardly a day passes but what we read of another situation where the United States Government, from the federal level to the local, has done something that is totally outside of the established American morals of our forefathers. These time-honored morals and customs of our forefathers have been replaced by a new code of ethics within our government system. What our forefathers termed good, as defined in the Holy Bible, is now evil. The evil as described in the Bible is now good.

"Woe unto them that call evil good, and good evil; that put darkness for light, and light for darkness; that put bitter for sweet, and sweet for bitter! Woe unto them that are wise in their own eyes, and prudent in their own sight! ([Isaiah 5:20-21](#))

A typical example is the case of the international banking firm known as BCCI. This banking dynasty was involved in the laundering of money for the international drug trade which involves high ranking officials. Another example is the tragedy of the Inslaw Corporation. This firm developed an extremely sophisticated computer software which was designed to improve the law enforcement agencies' data bank of criminal activities. The software was designed to be useful on a world-wide basis. The U.S. Justice Dept. contracted with Inslaw but after delivery was made they reneged. The Mossad in Israel wound up with the software. There have been assassinations over this immoral activity. It becomes obvious that the One-World Government now owns that system of total surveillance.

Evil governments throughout history have always developed systems to retain control over their people by using totalitarian means. As the world's technical capabilities become more sophisticated, the government's control becomes more total and more brutal. There is no exception here in the United States. For over twenty years, the United States government has been in the process of developing and perfecting a national police force and have concurrently made an untold expenditure of effort and money to establish a national concentration camp system. We can call it The American Gulag.

But perhaps the most sinister of all of these actions is the total disregard for the sanctity of human life. The history books display many examples of police brutality in the arrest, the lynchings and the imprisonment of Black men. Today, the Rodney King case notwithstanding, the primary target for police brutality is towards White men and women. Any White man or woman who opposes the One-World Government is a potential candidate for oppression.

Arthur Kirk was shot and allowed to bleed to death right in front of the police, simply for refusing to submit to foreclosure on his farm. Gordon Kahl was killed in Arkansas in the most bizarre manner by the federal police and Sheriff Gene Matthews was killed in the same incident because he would not go along with the fed's attempt to cover up what amounted to a "keystone-cop" scenario. Gordon Kahl was exposing the One-World Order and a drug

ring involving high officials in North Dakota. There are numerous other examples of such activity.

To make these immoral and unlawful activities palatable to the American public, massive conditioning of public opinion had to be accomplished. Thus, as the words of Isaiah teach us, *"Woe unto them that call evil good, and good evil; that put darkness for light, and light for darkness..."* The American public had to be convinced that these White men were evil. The current "buzz-word" in Washington circles for this phenomena is "spin-doctoring." There is a church camp scheduled for December in Florida. God willing, we intend to present a message describing how this phenomena works, when the government started using it and who developed it. The national news media, working in concert with the establishment in and out of government, has convinced the average citizen that all of these White men deserved to be killed.

There is another factor in the rationale of the government's decision for the national police force to be more brutal in its relationship with citizens who oppose the implementation of the New World Order. It is the significant change in the definition of "excessive force." Our forefathers, in 18th century America, followed the Common Law procedures for using deadly force. If, an escaping or escaped felon had committed any of the felonies that were punishable by death, then deadly force could be used. For example, murder, rape, sodomy, mayhem, arson and prison break were all punishable by death in early America. Deadly force could be used.

On the other hand, if the felon was wanted for any infraction that was not a death sentence, then, under no circumstances could deadly force be used. It made no difference if the arresting officer considered himself to be in immediate danger. That was expected in his job. The courts ruled, "To permit the life of one charged with a mere misdemeanor to be taken when fleeing from the officer would, aside from its inhumanity, be productive of more abuse than good. The security of person and property is not endangered by a petty offender being at large." (from a report by J. Paul Boutwell, Legal Council Div., FBI.)

As our government has become more totalitarian, the definition of felonies has changed. More and more misdemeanors become felonies and it has become increasingly more difficult for police officers to know when to use deadly force. As the present national police force was being developed, the police academies began teaching that "It was the citizen against the police and that the thin blue line was the only force that kept the ordinary citizens from killing each other." The courts responded to the government's demands that the national police force be protected at all costs. Consequently, the rules for the use of deadly force appear now to follow that old adage, "Kill them all and let God sort them out."

Those were the intentions during the last week in August in the mountains of Northern Idaho where we can see the latest example of the government's redefinition of the right to use deadly force. The Randy Weaver family moved from Iowa to the mountains near Naples, Idaho in the late 1980's. They wanted to live separated from modern American civilization. They wanted to teach their children at home using the Bible as one of their textbooks. Iowa didn't allow that. They believed what Paul said in [II Cor. 6:17](#), *"Wherefore come out from among them, and be ye separate, saith the Lord, and touch not the unclean thing; and I will receive you."* [Isaiah said in 52:11](#), *"Depart ye, depart ye, go ye out from thence, touch no unclean thing; go ye out of the midst of her; be ye clean, that bear the vessels of the Lord."* They moved to Ruby Ridge, near Naples, Idaho and built a cabin. It was a cozy cabin made of wood and was very similar to those little homes of our forefathers as they moved West. Yes, the Weavers are White and they are separatists. Yes, they understand "that bear the vessels of the Lord" means being a servant of God.

There is nothing in what Paul said in [II Cor. 6:17](#) and what [Isaiah 52:11](#) says that would lead the Weavers to believe they were White supremacists. The Weavers understood very well what being a supremacist meant. They left Iowa and headed for the mountains because they understood the meaning of the word. They saw it happening when privileged individuals from the establishment did as they pleased and made the rules as they went. They knew how those in the oligarchies interpreted the Golden Rule, "those who own the gold make the rules." They understood that people with names such as Rockefeller, Rothschild, Roosevelt, Kissinger, Clinton, Perot and Bush were considered supremacists. But then, the Weavers were "politically incorrect."

Randy Weaver, the father and husband, had been in the Special Forces during the Vietnam era. As we all know, the Special Forces are trained to a very high degree in all forms of intelligence, surveillance, close range personal combat and intentional political destabilization. Consequently, the government knows that they have developed a Pandora's box with the untold number of veterans of the Special Forces. They are known to keep very close track of them. Knowledgeable friends have stated that Randy had been assigned to an intelligence gathering mission on the East coast while on active duty. That mission had not been resolved.

Randy had heard of the Aryan Nations which has their headquarters at Hayden Lake, Idaho, reasonably close to Naples. Randy wanted to know what they were like and visited them. He found that they did not meet his personal needs so he quit attending. But that was enough to meet the needs of the government. What follows is extracted from the Midnight Messenger, Issue 45: 9205 S.E. Clackamas Rd., #1776, Clackamas OR 97015.

"Weaver is alleged to have sold two 12-gauge shotguns to a federal informant in October 1989. In December, 1990, he was indicted on firearm charges. After being set free pending a court appearance, he secluded himself in his cabin, refusing to leave. Weaver, a White separatist, claimed that he was set up and framed by the federal authorities because of his religious and political beliefs. Weaver also stated that the feds offered to drop the charges if he would serve as an informant against the Aryan Nations organization located in nearby Hayden Lake. He refused." (It has also been stated that the shotgun incident was a "sting" by the government just to set him up for the informant role they desired.-ed.)

"On Friday, August 21, Randy Weaver, 44, his 14-year-old son, Sam, and Kevin Harris, 24, a family friend who lived with the Weavers, were working around their mountain-top cabin when they heard one of their dogs barking. Believing that a deer, one of the family's staple sources of food, had been flushed out of the undergrowth by the dog. Sam and Harris, with hunting rifles in hand, ran down the hill toward the disruption. As they neared the dog, an unidentified man, wearing camouflaged clothing, sprang from the undergrowth and ordered them to freeze. A shot, fired by another man in camouflage nearby, killed Sam's dog. Angered, the teenager turned, screamed at the unidentified intruder who had just killed his dog, and fired his 30-30 rifle at the intruder. Harris also shot at the uninvited visitors."

"It was later revealed that U.S. Marshal, William Degan, of Quincy, Massachusetts, was apparently killed by one of the shots. Randy Weaver, who was nearby and heard the shots, fired his own gun into the air and shouted for his son and Harris to get back to the cabin. Responding instantly, they turned and headed towards the safety of the cabin. As they ran another shot rang out and the teenager, shot through the back by one of the intruders, fell dead. Harris paused long enough to determine that the 14-year-old wasn't breathing, then resumed his race for safety." (It has been later verified that Sam was shot three times, once in the arm, and twice in the back.-ed.)

"What was apparently unknown until later was the fact that the Weaver dog had flushed out a group of U.S. Marshals who were on a reconnaissance mission, checking out the Weaver property in preparation for an assault. The Marshals, who apparently didn't identify themselves, are said to have been trespassing on the Weaver property. They had no warrant, or indeed permission from the local sheriff to be operating in his exclusive jurisdiction, when they were flushed out by the Weaver dog. Apart from an amazing series of circumstances, this startling information, and the Marshals' modus operandi, may well have been permanently withheld from public knowledge."

"That night Sam's father and mother recovered his body, bringing it back to the cabin. There, watched by the teenager's 16 and 8-year-old sisters, they cleaned the body and wrapped it up in sheets, preparing it for burial. They later left the body in a nearby woodshed."

"The next day (August 22) Randy Weaver went out unarmed to see his son's body, to say a prayer over him and sit by the body. As he reached to open the door of the shed a shot rang out: a bullet struck him in the armpit, entering from behind and exiting to the front. Shouting to Harris who was nearby to get back into the house, Weaver also ran for the house and Vicki Weaver, who was holding her 10-month-old baby in her arms, held the door open for them to enter. As the men rushed through the door, another shot rang out. A high powered bullet struck Vicki between the eyes, killing her instantly. Miraculously, her baby was unharmed. Fragments of the bullet and/or Vicki's skull hit Kevin Harris, wounding him badly in the chest. Apparently, in this incident, which occurred on the second day, no shots were fired by Weaver or Harris."

"With his dead wife lying on the kitchen floor, and the lifeless body of his only son lying out in the woodshed, Weaver and his two daughters sealed off the various openings in the house, leaving the interior in almost total darkness. It was to remain that way for more than a week. Shortly thereafter, the cabin was surrounded and sealed off by hundreds of highly trained, heavily armed federal officers."

"It was later revealed by Sara Weaver, 16, who survived the hideous ordeal, that although the federal agents knew two days after the siege began that Vicki Weaver had had her head blown off by one of their snipers, and that her 14-year-old son Sam was also dead, they waged psychological warfare on the remaining members of the Weaver family. 'They'd come on real late at night and say, 'Mrs. Weaver, How's the baby, Mrs. Weaver?' in a real smart-alecky voice. Or they'd say, 'Good morning, Randall. How'd you sleep? We're having pancakes. What are you having?' It was like psychological warfare. It made me so mad. Sara told a harrowing tale of cowering in the cabin, listening to her 10-month-old sister, crying, 'Mama, Mama,' as federal troops lit the cabin with spotlights and tried to coax the family to the door. 'I was praying that if they were going to kill us, they'd take us all at once, because I couldn't stand to see any more of my family hurt. I couldn't watch them pick us off one at a time. I was praying that they would just firebomb us.' (Interview with Sara Weaver by Spokesman-Review, Spokane, quoted in The Oregonian, September 3, 1992)." End of the quotes from the Midnight Messenger.

The federal officers had intended to torch the mountain cabin, thus incinerating all of the occupants, in a manner similar to the Gordon Kahl case in Northern Arkansas. It seems that when things go badly for the national police force, they want to burn all evidence. They were observed taking a satchel charge and placing it near the cabin. Then, they were observed filling a container with diesel fuel and putting it on board a helicopter. As the federal officers took off in the helicopter to drop the diesel fuel on the cabin, they were observed by a television camera crew filming the entire event. When the attendant reporter

stepped out to wave, letting them know they were being observed, the helicopter returned and landed. The cameraman was arrested for "obstruction of justice."

Randy Weaver had served with Col. Bo Gritz at Fort Bragg, N.C. Knowing this, the FBI contacted Col. Gritz to secure his services to talk Randy Weaver out of the cabin. Col. Gritz responded to the request and arrived on the scene with retired police officer Jack McLamb from Phoenix, Arizona. Randy knew Bo Gritz and trusted him. He allowed him to come to the cabin and a visit ensued. It was agreed that Kevin Harris would be taken to the hospital in Spokane because he was the most seriously wounded. Harris agreed to go only on the provision that Jack McLamb would go with him to the hospital because he did not trust his life with the federal officers. Then, the next day, August 31, Randy, with what remained of his family, came down off the mountain.

Yes, there has been a change in the definition of a felony and the authority to use deadly force in the making of an arrest. Our forefathers received their definition of a felony worthy of death from the Holy Bible. But now our nation has turned humanist. The Bible is ridiculed and ignored. Totalitarian governments make their own rules and there is no sanctity to human life.

Americans are awakening. The Weaver case has reached the hearts and minds of a great portion of the public. The controlled news media has intentionally ignored the incident for the most part except to editorialize that they deserved everything they got. But true Americans don't believe that. Even if Randy was guilty of selling two shotguns that were too short (even though the second amendment doesn't specify how long the barrel should be), it was not a felony, according to Common Law, which warranted death.

Americans everywhere are demanding a change. They want the "line drawn in the sand" on this issue. They do not want to see another incident like this. Accordingly, a meeting was conducted October 23, 24, and 25 to come to a mutual understanding and to develop a uniform response to any flagrant violation of what we as Americans hold inviolable. Only Christian men were invited and leaders from nearly all walks of Christianity were present. There were stirring messages given by these leaders of their own activities. Prayers were given to ask God for strength, wisdom and courage. The meeting broke into several committee meetings in accordance with a pre-set plan.

The greatest blessing that came from that meeting was the unity of purpose in the minds of these leaders. They left the meeting realizing that these "separatists" and "supremacists" were not at all what they had been taught by the planted disinformation and misinformation of the news media and the government.

It is not the attempt here to pre-empt the details of those committee actions. That will be accomplished by Pastor Pete Peters of Scriptures for America. He intends to present a message on those results with excerpts of some of the messages in the near future. It is sufficient to say that everything that was accomplished was done in a Godly and lawful way.

Lesson In History Part 19

This lesson will be a continuation of [lesson 18](#) in which we showed that the current craze for a "One World Order" is a very old concept. For many years nobility from all parts of the world, along with the wealthy, have combined forces to create oligarchies, which is the ruling by a few with money and position. The Word of God is very clear as to how government is to be formed. God's system is a true republican form of government and as long as His system is followed we all prosper and we have freedom and liberty.

In the [first chapter of Deuteronomy](#), Moses told the children of Israel that they themselves would provide the government over the people of the nation. Quoting Moses starting in verse 9:

"And I spake unto you at that time (referring to [Exodus 18:18](#)), saying, I am not able to bear you myself alone: The Lord your God hath multiplied you, and, behold, ye are this day as the stars of heaven for multitude. (The Lord God of your fathers make you a thousand times so many more as ye are, and bless you, as he hath promised you!)"

"How can I myself alone bear your cumbrance, and your burden, and your strife? Take you wise men, and understanding, and known among your tribes, and I will make them rulers over you. And ye answered me, and said, The thing which thou hast spoken is good for us to do."

"So I took the chief of your tribes, wise men, and known, and made them heads over you, captains over thousands, and captains over hundreds, and captains over fifties, and captains over tens, and officers among your tribes. And I charged your judges at that time, saying Hear the causes between your brethren, and Judge righteously between every man and his brother, and the stranger that is with him."

"Ye shall not respect persons in judgment; but ye shall hear the small as well as the great; ye shall not be afraid of the face of man; for the judgment is God's: and the cause that is too hard for you, bring it unto me, and I will hear it."

Moses was the spokesman for God. He provided the same function as the Holy Bible should do for us today. Our government would then be true republicanism with God solving the "hard" problems.

But that isn't the way it is and as we study our history, we find only brief periods of time when some of the nation's leaders tried to follow the directions given to us in God's Word.

[Lesson 18](#) revealed that the Boston Brahmins and the oligarchies they represented wanted to destroy the United States as soon as it was created. The Civil War was conceived before the year 1800. The proof of this is unequivocal. The names of the perpetrators are now considered famous and we have universities, towns, military installations, parks and government institutions named after them. Again, as we have stated many times before, the victor always writes the history.

We showed that even Presidents were involved, along with Congressional leaders, Secretaries of State, Foreign Ambassadors, Army Generals and leaders in industry. It was Caleb Cushing, whose family was involved in the Chinese Opium trade as well as the slave trade, who prodded Presidents Tyler and Polk in their efforts to bring on the Civil War. Concurrently, Cushing trained the famous William Lloyd Garrison, editor of the widely read *The Liberator* newspaper. All the while that Garrison was extolling the freeing of Black slaves, he was inciting the British into action with speeches about the dissolution of the United States.

In this lesson we will continue with the actions leading to the Civil War, which was designed to create a new empire for the oligarchs. The War with Mexico must be included because it, too, was a part of their dreams for an empire of their own. As we shall see, the "taming" of the American West was very much regulated and controlled by these same families. Even though all of these actions at least partly failed, the families of these original perpetrators are still very much in command.

Down through the years the use of Hegellian Dialectics to manipulate the affairs of a nation has become a science. It has become so intricately developed that many times several issues are manipulated simultaneously, which makes history appear as "accidental." The United States Civil War is a classical example. The Boston Brahmins and the oligarchies created the Civil War with the intent of establishing a new empire out of a part of the United States, along with Mexico and Cuba. Had they won the Civil War they would have succeeded in their goal. However, the dialectics was developed in such a manner that, if they lost the Civil War, they would still have won their goal. The losers, as usual, would be the citizens of both sides, known to the oligarchies as "cannon fodder." In the common vernacular such multiple dialectics is called the "cross" and the "double-cross." As we continue with our history lesson, we will realize that the Civil War was that type of complex dialectics, conducted by the masters of intrigue.

While Caleb Cushing and William Lloyd Garrison were doing their work, other men were also very active. The citizens of America had to be convinced that the Civil War was inevitable, even necessary. So Caleb Cushing, then U.S. Attorney General under President Pierce, with the bill written by William Seward, was able to get the Kansas-Nebraska Act passed in Congress. This law repealed the Missouri Compromise which prohibited the establishment of slave states north of the southern border of Missouri. Here was a man, supposedly against slavery, along with William Garrison, getting an anti-slave law repealed, not because of a conviction but for ulterior motives. These are the type of actions which produce traitors.

The Kansas-Nebraska Act very cleverly provided for the creation of the states of Kansas and Nebraska out of the then Nebraska Territory. The act also specifically provided that the people of Kansas and Nebraska would decide for themselves if they wanted slaves or not. What a perfect set-up for inciting bloodshed and for good, decent citizens taking sides!

To show that the new law was an outright setup to incite Americans to war, William Seward, the writer of the bill, said to the Senate after its passage: "Come on then, Gentlemen of the Slave States, since there is no escaping your challenge, I accept it in behalf of the cause of freedom. We will engage in competition for the virgin soil of Kansas, and God give the victory to the side which is stronger in numbers as it is in right."¹ What blasphemy to invoke the name of God to incite the terrible carnage that was to follow!

To provide a little of the "cannon fodder" for the bloodshed, the state of Massachusetts established an official charter for the "Massachusetts Emigrant Aid Society" which was to provide emigrants to settle the West. The idea was pushed in the *New York Tribune* owned by none other than Horace Greeley. The newspaper articles pushed the idea that 20,000 abolitionists (those who oppose slavery) were moving into Kansas. This was an outright incitement to bloodshed.

To counter this move, citizens in Missouri were instigated into organizing the "Platte County Self-Defensive Association" for the stated purpose of removing all emigrant abolitionists from Kansas, who were a part of the Northern Emigrant Aid Societies. The members of the Platte County Association openly murdered emigrants and committed arson of their property to prove that they were serious.

To further excite God-loving Americans into action, the infamous John Brown came into play. John Brown was funded by the money of the Boston Brahmins, the master agitators of the oligarchy that was attempting to destroy the United States. Gerrit Smith of New York provided the funds for the evil carnage accomplished by John Brown. Gerrit Smith was a member of John Jacob Astor's group, another member of the oligarchy. The Astor family made their money in the slave trade, the Chinese opium trade and the slum dwellings of

New York. Gerrit Smith owned a one-million acre piece of property in New York inherited from an Astor connection. John Brown lived with Smith on that property. Another principal backer of John Brown was the famous Boston Brahmin, Thomas Higginson.

John Brown, his four sons and three other members of his gang, attacked a Kansas pro-slavery settler named James Doyle. While his wife watched and pleaded, Brown dragged James Doyle and two of his sons outside. He shot the father, split open the skulls of the sons and hacked all of the bodies to pieces.

They also attacked a pro-slavery Kansas Legislator named Allen Wilkenson by hacking open his skull in front of his wife. Then they went to another house and split open a man's skull, slashed open his side and cut off his hand. It should be noted here that cutting off a hand or foot is one of the signs of the secret societies and of the occult.

What would be the next logical course of action? Samuel Cabot, another of the oligarchy, along with Amos Lawrence, the prime stockholder of the Emigrant Aid Society, sent a great number of Sharp rifles into Kansas. This ostensibly was to allow the Kansas settlers to be able to protect themselves, of course!

John Brown was in communication with Thomas Higginson and William Garrison. The Massachusetts State Kansas Committee, directed by Higginson and Garrison, gave Brown money for 200 revolvers. The National Kansas Committee, met in the Astor home and delivered supplies for 100 men and \$5,000.² While Brown was committing mayhem and planning with the oligarchy in these meetings, the Attorney General Caleb Cushing just couldn't catch John Brown!

Thomas Higginson introduced Brown to Hugh Forbes, a British soldier of fortune, and together they travelled to Iowa where they trained Brown's army for the work yet to be done. The money to pay the soldiers of Brown's private army and the costs for the training came from the Boston Brahmins. Of course, the money originally came from the slave trade and the Chinese opium trade. (We all by now should be aware of the involvement of high ranking government officials, the modern descendants of the Boston Brahmins, in the current drug traffic. We should be able to deduce where some of the profits are going.)

Brown took his freshly trained "army" to Harpers Ferry, Virginia and on October 16, 1859 attacked the U.S. Arsenal. In the fight Brown was captured, tried in court and was hung as a traitor. Brown was immediately made into a martyr by the Boston Brahmins and their newspapers such as William Garrison's *The Liberator*. They also took the opportunity in their editorials to show Brown's allegiance to abolition and his hatred for the South. This created further division between North and South.

Now for perhaps the most important issue in this man-made Civil War of the United States (We all should know that wars don't just happen). Brown was only an agitator like the picador in a bull fight who throws the little lances into the bull's back just to irritate and excite him.

In 1853, Mr. J.J.J. Gourgas du Pan de Rengers, a nobleman from Switzerland, was the master of the Northern Jurisdiction of the Scottish Rite of the Freemasons in the United States. This man gave the specific orders to Mr. Killian Van Rensselaer of upstate New York and another leader of the Scottish Rite, to develop and take personal control of a paramilitary organization. The purpose of this organization was to provide the insurrectionary force to initiate the actual fighting of the Civil War. Rensselaer (the family name of the Rensselaer Polytechnic Institute) moved his planning and operations to Cincinnati, Ohio.

The name of the insurrectionary force was "The Knights of the Golden Circle". The name was derived by drawing a circle on a map with, the center in Havana, Cuba and the radius of the circle 1500 miles. This circle represented the new empire that was to be created out of a destroyed United States and Mexico. The destruction of Mexico was a part of their plan. Remember, the War with Mexico was concluded in 1845 with the Treaty of Guadalupe Hidalgo. In [lesson 18](#) we showed that it was Caleb Cushing who was very active in organizing the War with Mexico.

Rensselaer then went on to organize training centers in all of the major cities of the South. The Knights of the Golden Circle boasted 65,000 members (troops) at the outset of the Civil War. The "Knights" influenced public opinion in the South with meetings, newspaper releases and personal canvassing. As with any totalitarian type government, they also would be used to "physically persuade" any open opposition as would be necessary. The Knights of the Golden Circle openly conducted military training and maneuvers throughout the South. The European papers carried these stories on a regular basis.³

The Knights of the Golden Circle was the military arm of the Scottish Rite's efforts to bring on the Civil War under the guidance and funding of the Boston Brahmins. The Scottish Rite also provided men to work in the political arena for the same purpose.

Caleb Cushing had as his protegee for several decades a man named Albert Pike. It is not known if Cushing indoctrinated Pike in his morals and religious beliefs but he certainly taught him who rules the world and the part he was to play in it. Pike was a known Satanist and practiced phallic worship.

As soon as Caleb Cushing was sworn in as Attorney General, Albert Pike was given the highest degrees of the Scottish Rite of Freemasonry in 1853 at the Rites Southern Headquarters in Charleston, South Carolina.

Albert Pike was assigned the job of developing the political organization and leadership of the secessionist movement to compliment the military assignment that was given to Rensselaer and his Knights of the Golden Circle. Pike organized and developed the Supreme Council of the Southern Jurisdiction of the Scottish Rite for the purpose of providing the leadership, communications, networking and command of the secessionist movement. He chose Charleston, South Carolina as their headquarters. It was in his capacity as Grand Commander that Albert Pike wrote the famous (infamous?) *Morals and Dogma* which is still being used as doctrine for the Masonic Movement in the United States. One should ponder if modern day Masons know the history behind the Supreme Council of the Southern Jurisdiction?

There are many well-known names in American history who were members of the Scottish Rite (undoubtedly because of Albert Pike) and who were very active in the preparation for the Civil War. In 1860, Howell Cobb of Georgia became a Sovereign Grand Inspector General and member of the Supreme Council. Howell Cobb was Secretary of the Treasury of the United States and at the same time he was a leader of the Georgia secessionists. Another member of the Supreme Council and a Sovereign Grand Inspector General of the Scottish Rite was the Vice President of the United States, John Breckinridge. The secessionists nominated him to be President of the South because of his leadership. Of course, we know that he was not elected President.

Caleb Huse was a Northerner from Newburyport, Massachusetts and his family, owned the *Newburyport Herald* where Caleb Cushing and William Garrison had worked. Obviously, Caleb Huse was influenced by Caleb Cushing, William Garrison and Albert Pike. Caleb Huse moved into the South and was in charge of the Alabama militia. After the war started he

went to England and was extremely influential in obtaining significant amounts of armament and ammunition. Huse is another example of a man who outwardly spoke for the cause of abolitionism and then furthered the cause of the South. Such actions are further proof of a conspiracy.

Albert Pike had placed Scottish Rite associates in the political machinery of all the southern states. Howell Cobb of Georgia was a Supreme Council member. Robert Toombs was another Supreme Council member in Georgia. Both of these men were very active in the politics of secession. Howell Cobb was the chairman of a meeting of political leaders of the states of Florida, Georgia, South Carolina, Mississippi, Alabama and Louisiana. Again, this shows the political leadership of the Scottish Rite among the secessionist states.

All of these men from the North, dupes and lackeys of the oligarchies in the United States and Europe, did their jobs well. They penetrated the South and agitated and convinced the common citizen that the Civil War was inevitable. The Knights of the Golden Circle provided a little "persuasion" whenever it was needed. All the while, they did the same thing in the North agitating and persuading the people of the North that the War was inevitable. It was the same people controlling both sides.

It was time for the war to begin. It is accurately stated by the historians that the first act of war was at Fort Sumter, South Carolina. Here again, the same detestible plotters set it in motion. The newly elected President Lincoln, recognizing that the situation at Fort Sumter was volatile, ordered a full squadron of gunships and troopships to sail for Fort Sumter to reinforce the garrison there. William Seward, who was then Secretary of State, sent a secret message to the Squadron Commander directing him to proceed on to Florida which, of course, would be out of the action area. The Squadron Commander thought the message came from the President and so he obediently complied (at least this is the established understanding).

This was the same William Seward who, while he was a Senator, challenged the leaders of the South to fight it out on the virgin soil of Kansas with the abolitionist emigrants from New England after the Nebraska-Missouri Bill was passed in the House of Representatives.

The Squadron was redirected back to Fort Sumter after President Lincoln was told what William Seward had done. But it was too late. The Squadron Commander put his fleet at a safe distance off Charleston and waited out the battle. Fort Sumter fell and the Civil War was on. It was the Knights of the Golden Circle that was the insurrectionary force that attacked Fort Sumter.

It is most interesting and germane to note that Jessie James, the famous desperado of the period after the Civil War, was a member of the Knights of the Golden Circle and was a 33rd degree Scottish Rite Mason! He fought with the insurrectionary force at Fort Sumter. We will discuss Jessie James and other desperados of the period as examples of what often times happens when the "double-cross" of the dialectics is recognized for what it really is. [5](#)

The actual gory details of the War have been written over and over by well-known authors. It is not the purpose of this lesson in history to cover that aspect. We are showing the conspiratorial aspects of that war. There was a conspiracy then and there is a conspiracy now. The proponents of that conspiracy remain unchanged. Each succeeding generation of conspirators simply changes the name of the conflict but as these lessons continue we will realize something in common among the leaders. By studying the geneology of the names of the conspirators down through the generations, the same family names appear over and over again!

Now for another facet of the conspired "Golden Circle Empire." We Americans have been told for 200 years that our customs, mores, laws and our civilization itself have come from England. We are told that England has been our closest friend and ally over these many years. This is taking a little truth and stretching it to the limit. England before William the Conqueror in 1066 A.D. was not the same as it has been since. Ancient England was Celto-Saxon and it was through them, from, and through, Saxony, that our Common Law came. It did not come from the England after William the Conqueror.

The England of William the Conqueror, Oliver Cromwell, King George III and all of those following is the England of Merchant Bankers culminating in the Bank of England and that "One-Square-Mile" known as "The City" in London. The United States of America has been at war with that bank ever since the Revolutionary War. The War of 1812 was with that bank. The Civil War was with that bank. The war supposedly ended when the Federal Reserve System, a mirror image and a lackey of the Bank of England, was initiated in 1913. Past Lessons in History have explained this so we will not dwell on this part of history here.

So our "friends and allies" in England were busily equipping the South in order to successfully end the war with the "Golden Circle Empire" coming out as the winner. They also went on the offensive in another part of the "Golden Circle." To refresh our memories, that circle was centered in Cuba and had a radius of 1500 miles. Mexico was considered to be within the circle as were parts of the Southwestern United States.

Mexico was at that time, and still is, one of the wealthiest nations in the world in natural resources. The "Golden Empire" needed those natural resources. Consequently, in 1862, Mexico was invaded by a multi-national army from Europe.

England, under the rule of Queen Victoria and her husband Prince Albert, was the leading force. King Leopold I of Belgium, who just happened to be the uncle of Queen Victoria, developed the details of the plan. (It's all in the family, of course.) Arrangements were made to use the forces of England, France, Belgium, Spain and Austria to invade the ill-equipped, poor nation of Mexico.

Here is another example where the multi-faceted dialectics, or "double-cross," was used to advantage by the international bankers with their headquarters in "The City." An agreement was signed in "The City," of course, to send an expeditionary force into Mexico to recover the money from a blatantly unjust loan made to Mexico from an oligarch bank in Switzerland. It was the same type of deals that Bosky and Millican contrived recently here in the United States. Forces from England, Spain, France, Austria and Belgium invaded Mexico, just to recover the money lost by a merchant banker. England, where the agreement was signed, sent only 700 marines! Knowing exactly what they were doing they, along with Spain, pulled their troops out in only several weeks. The other nations, leaving only France holding the bag, pulled out shortly afterwards. Arrangements were also made by the money lenders to send Maximilian and Carlotta to be King and Queen over Mexico. It was no coincidence that Carlotta was the daughter of King Leopold (the uncle of Queen Victoria of England!).[6](#)

If the U.S. Civil War were won by the "Golden Circle Empire" the king and queen would already be on their throne. But, if the North won the war, the oligarchy would still be in total command of the government of the United States and, as history has proven, the merchant bankers and their money system, would rule. "Heads I win, tails you lose!"

The French forces in Mexico were attacked by a well-organized guerrilla type army under Benito Juarez. Juarez was already a seasoned guerrilla chief in Mexico's history of that type of combat. It was but another example of how dedicated guerrilla forces can wear down a vastly superior army and cause them to capitulate. The French forces were forced to retreat, leaving Maximilian behind. Carlotta was allowed to escape but she went insane because of the ordeal. Maximilian was executed.

There is another lesson to be learned here. Those within the oligarchies have very little feeling for others, even within their own groups. They are like sharks that will consume anything in their way. They do have a certain code of ethics within their groups. That code of ethics, however, is very much like that of the Mafia. The oligarchies, too, don't mind destroying each other. Notice how easy it was for the French King to leave Maximilian deserted in Mexico to be executed. The same thing happens here in American politics, the current Presidential race included.

The Civil War was concluded in the United States and President Andrew Johnson, who followed after Lincoln's assassination, sent troops to the Mexican border to allow weapons and equipment to be transferred to Juarez's forces to complete the routing of the French army in Mexico.

As the South began to realize that the war was being lost, many of the "Knights of the Golden Circle," along with other leaders in the South, deserted to Mexico. They thought that, at least, they could have that part of their "Golden Circle." They were given one million acres of Mexico by the French in much the same way that millions of acres were turned over to individuals by Spain during that conquest. But, as that part of the "Golden Circle" was also lost, they returned to the Western United States where they believed that they could still retain a little part of the empire. The history lesson must continue with that part of this saga. What drove the desperados to action? Was Jessie James a part of it? What about Billie the Kid and the rest of them? Were they connected in any way to the Knights of the Golden Circle and Freemasonry?
