Sire of Merit: A male Amstaff who sires 10 AKC registered titled get; may be awarded the title of Sire of Merit by the Staffordshire Terrier Club of America. AKC titles that are included are conformation champion and various obedience and agility titles. The titles can solely come from obedience, conformation, or agility, or any combination of the three, but must be from 10 different get.

Dam of Merit: A female Amstaff who produces 5 AKC registered titled get; may be awarded the title of Dam of Merit by the Staffordshire Terrier Club of America. AKC titles that are included are conformation champion and various obedience and agility titles. The titles can solely come from obedience, confirmation, or agility, or any combination of the three, but must be from 5 different get.

AKC Conformation titles that count toward the title of Sire/Dam of Merit are

AKC Conformation Championship or Grand Championship

AKC Performance titles that count toward the title of Sire/Dam of Merit are

Obedience

RA, CD, UD

Agility

All agility titles will be accepted

Upon completion of the above qualifications the STCA member must submit the information to the committee. Certificates will be awarded at the annual awards banquet. In cases of co-ownerships, only the owner who has applied for award will be presented with a certificate.

*Only the owners who are present at the STCA annual banquet will receive a certificate. Any certificates that need to be mailed will be charged a handling fee of \$5.00.

This is a draft proposal and further refinements will be forthcoming.

An application form will be made available on the club's website.
