

9/17/2018

Deputy Schuerman assisted Squad 4 with lifting a patient.

Deputy Schuerman responded to a tree in the roadway on State Route 26 in Wayne Township. Deputy Schuerman remained on scene until ODOT removed the tree from roadway.

Sgt. Smith spoke with a citizen regarding damage that occurred to his vehicle due to poor road conditions. The citizen was referred to the ODOT claim form for damages.
