A non-refundable deposit of \$75.00 per session must accompany the registration form. The final balance is due by April 29, 2016. Registrations submitted after April 29, 2016 must be accompanied with the full payment.

Refund Policy: Withdrawal on or before April 29: All tuition except deposit refunded; Withdrawal after April 29: No refunds.

Registration is confirmed only after I pay the final balance due by April 29, 2016. *If registration is made after April 29, 2016 payment in full must accompany this registration form. The tuition for each session is \$200.00. Early Bird Discount: Register by Feb. 29, 2016 and pay only \$175 per week. Please make checks payable to BHPCNS. Early Drop-Off: Pre-registered campers may be dropped off at 8:00 a.m. for an additional \$40.00 per session. A camper may "drop-in" early if space allows at the rate of \$15.00 per day. Camp ends at 12:30 p.m. All children must be picked up promptly each day. A fee will be assessed if I pick up my child late. Late pick up fees are as follows: First 5 minutes - \$5.00; Over 5 minutes - \$2.00 per minute (i.e. 7 minutes = \$14.00). This fee must be paid upon pick-up of child.
