# PORT OF MANCHESTER MINUTES

## December 11, 2017 Manchester Library Meeting Room, 8067 E. Main Street

#### REGULAR MEETING

**Call to Order**. Board President Strode called the meeting to order at 6:00 PM. Present were Commissioners Strode, Fallstrom and Peterson. Also present were Contract Administrator O'Connell, Attorney/Auditor Thompson, and 9 guests.

## 2.0 Approvals - Consent Agenda

- 2.1 Regular meeting minutes for November 13, 2017
- **2.2** Vouchers numbered 17-151 through 17-163 in the total sum of \$2,963.47. After discussion, Commissioner Pedersen moved approval of items 2.1 and 2.2 of the consent agenda. Commissioner Fallstrom seconded the motion. Passed unanimously.
- 3.0 Public Comment. There was a good turnout of people to observe the passing of vessels with Christmas decorations last Friday evening. The tree decorations look very nice. There followed discussion concerning the location of Wi-Fi antennas on Port property. There is some concern about view blockage, and other concern is that there should be compensation to the Port for the use of Port property for a commercial activity. The company seeking to install the system is offering free Wi-Fi to all persons using Port facilities. The representative representing the Wi-Fi interests was not present for this meeting, so no action was taken.
- 4.0 North Dock Repairs Contract Administrator O'Connell reported that Marine Floats have made replacement of some hinge pins between floats that have been worn to a point of requiring replacement. It requires an expert to do this work, as the materials are not readily available. Marine Floats accomplished all this work under warranty, and without charge to the Port.
- 5.0 Financial Update Contract Administrator gave a written and an oral report about projected year end financials. It appears that the Port will end the year with approximately \$120 more than budget, so we are right on target with our income and expenditures. This is the last year of high debt service on our general obligation bonds, as the annual payment will reduce by over \$10000 next year.
