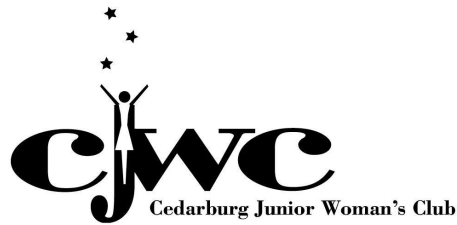

Booth Space Information

The booth size is approximately 8'x8'. However, sizes of a couple of booths may vary slightly due to the location of permanent walls in the Cedarburg Cultural Center. If you require electricity for your booth, you need to bring extension cords and tape to secure the cords to the floor. Individual booth assignments are made to create an appealing mix of media. Assignments are at the discretion of the CJWC Spring Market Committee members. While we attempt to honor specific space requests, no guarantees can be made.

Set Up Times

Set up on Saturday will be from 7:00 a.m.-9:30 a.m. Doors open at 10:00 a.m. A vendor continental breakfast will be included in your booth fee. Each exhibitor is responsible for supplying, erecting and taking down their displays and booth. Exhibitors are expected to stay with their displays and remain open during the entire length of the show.

Sales Tax

Each exhibitor is responsible for collecting and reporting sales tax (5.6%).

Publicity

Ads will be placed in the local newspaper and posters will be distributed locally. We will also utilize social media and our CJWC constant contact list to advertise, as well as our CJWC website. As a vendor in our show, we would be very appreciative if you'd help publicize the show. We will send you information via email that you can forward on to help us spread the word.

The Cedarburg Junior Woman's Club makes every effort to safeguard exhibitors and their personal property during the show. Exhibitors agree to hold harmless the show management, the Cedarburg Junior Woman's Club and the Cedarburg Cultural Center for any loss or damage resulting from the exhibitor's show participation.

Please note: If you need to withdraw after your acceptance, your booth fee will be returned minus a \$10 withdrawal fee. **Any artist withdrawing less than 30 days prior to the show will forfeit their entire booth fee.**
