The dash will be run at **12noon** with all competitors in the Parade Ring by **11:30am**.

Declarations to be made by 11am.

Rosettes 1st – 6th & Prizes 1st-3rd will be given to the first TB and Non-TB horses

A Challenge Cup will be presented to the first TB horse

The "Kingleighs" Challenge Cup will be presented to the first Non-TB horse.

A Cashmere/wool mix Poncho donated by Luella of Winchombe will be presented to the "Best Dressed Lady"

Race may be divided if safety factor is exceeded.

The "Concour d'Elegance" (turn-out & elegance) will be judged in the Parade Ring at 11:30am with Rosettes 1st-6th) Competitors may enter this section only.

Rosettes & mementoes to all Competitors.

Entry Fee £30 or £20 for Concour d'Elegance only.

Rules & conditions

Skull Caps (no fixed peaks) with chin strap to at least the PAS015-2011 standard must be worn for the dash. Competitors will not be penalised in the "Best Dressed" or "Elegance" judging for wearing a skull cap however "Silk Hats" may be worn for this section.

Body protectors must be worn for the dash and must conform to current standards and be of at least Beta Level 3 (purple Label) 2009 or later.

Vaccinations – All horses must be up to date with flu vaccinations following current BHA regulations and passports will be checked. Note the BHA may amend these regulations in respect to "Equine Influenza Precautions" nearer the time of this event. All competitors will be notified if this should occur.

The hunt, the organisers and their agents will not be held responsible for any loss or injury how so ever perceived. Participating in this event is done so at the riders own risk. All Competitors must have Public Liability Insurance.
