ection 3: HAZARDS IDENTIFICATION

MERGENCY OVERVIEW

DANGER. Extremely flammable. Contents under pressure. Harmful or fatal if swallowed. Aspiration hazard if swallowed. Vapor harmful. Keep away from heat and flame. Can cause nervous system depression. Clear spray with solvent odor.
