1.	I agree to adopt this dog as a member of my household, providing him/her with a permanent, loving home. I pledge to be a responsible pet owner and provide my adopted pet with food, fresh water, shelter, love, affection, and medical care at all times. I recognize that there are financial, physical, and mental responsibilities involved in having a pet, and I accept these responsibilities.
2.	It is understood that MCMM Rescue has acted as an adoption agency that houses stray and abandoned animals. Therefore, I do not hold MCMM or its representatives responsible for the long-term health or temperament of the animal I adopt.
3.	I accept full responsibility for the dog I am adopting and hereby release and discharge MCMM Rescue and all agents volunteers, and representatives from liability for any injury or damages to any person or property caused in the future by this dog, and from any clauses of action, claims, suits, or demands whatsoever that may arise as a result of such injury or damages.
4.	I understand that at the time of adoption MCMM Rescue, has provided this dog with the vaccinations that are appropriate for its age. I also understand that any boosters that are due to be administered after the date of this contract are my personal financial responsibility, and MCMM will not reimburse any of these expenses.
5.	I agree to provide this dog with veterinary care upon sickness, disease, or injury. I will take him/her to a veterinarian at least once a year for an annual health examination and routine vaccinations.
6.	In south Louisiana, dogs are susceptible to being infected with heartworms that are carried through mosquito bites that can happen year-round. I agree to give the dog I adopt heartworm preventative on a year-round basis (even during the winter months) using either daily or monthly treatment options.
7.	I hereby guarantee that I will not allow this animal to reproduce and add to the animal overpopulation. I agree to have the proper surgery for this animal to ensure this end (spay or neuter) if he/she is not already altered. In the case of a puppy, the surgery will be done before it is 6 months old
8.	I will provide this dog with humane care and maintain him/her in accordance with all current and future state, parish, and municipal laws and ordinances. I recognize that I am accepting an important responsibility towards the people living in my community. I understand that I will be responsible for any damages that my dog may cause.
9.	I will provide this dog with a fully fenced yard. I am accepting this dog as a household, family pet and companion animal. He/she will NEVER be kept chained, tied, or cooped in a small pen. I will not allow this dog to roam free and unattended. I will never transport this dog in a truck bed
10.	I agree to keep this dog for the length of his/her life unless extreme circumstances prevent it. I agree never to abandon this animal at any other shelter, a pound, on the street or in any other location.
11.	If I cannot keep this dog for the duration of his/her lifetime, I will immediately notify MCMM
