

**Marysville Township**  
**MONTHLY BOARD MEETING**  
**Monday June 24<sup>th</sup>, 2019**

**Meeting:** The meeting was called to order by Chair Augie Riebel at 7:00 PM. Members present: Augie Riebel Chair, Jane Hurley Supervisor, Debbie Uecker Clerk-Treasurer, Marty Randal Deputy Clerk-Treasurer, Ron Boehlke Road Maintenance and 9 residents. Joe Hickman Vice-Chair & Bob Casey Road Maintenance were absent.

**Pledge of Allegiance:** Recited.

**Meeting Minutes:** A motion to accept the May 20<sup>th</sup>, 2019 Meeting Minutes was made by Jane Hurley, 2<sup>nd</sup> by Augie Riebel and carried 2-0.

**Treasurers Report:** The beginning balance for June 2019 is \$17,827.08, receipts of \$226,431.92, expenses of \$118,483.82 and ending balance of \$125,775.18. A motion to accept the Treasurers' report was made by Jane Hurley, 2<sup>nd</sup> by Augie Riebel and carried 3-0.

**Old Business:**

1) Driveway requirement permit was discussed a draft form of the permit was presented. There will be no fee for the driveway permit. The Road Maintenance employees will inspect the driveways. The board will present the plan to Wright County Planning and Zoning.

**New Business:**

1) The condition of DeSoto Ave was discussed with the landowners of DeSoto Ave as the road is currently in an unsafe condition. Marysville Township inherited the asphalt road from Wright County when it was turned back to the Township. Marysville has no other asphalt roads and we do not have the funds or equipment to maintain the road.

Questions were raised on traffic counts as there is 2 homes and a gun club on the road. The Gun Club has shooting four nights a week and every weekend.

An option was discussed of removing the remain asphalt that we could do with Township equipment and put the road back in a gravel as it is pretty much a gravel road now.

Milhausen would be willing to pay to fix the road up to his property only.

Another option is the get recycled blacktop and spread it on the road with dust control and the four property owners would be responsible to pay for it.

This item was tabled until next month meeting.

2) Wright County Ordinance is discussing an ordinance change to its current ordinance of having a temporary mobile home. Russell Martie resident of Wright County requested the ordinance to be a permanent structure versus temporary. A motion was made by Augie Riebel, 2<sup>nd</sup> by Jane Hurley to leave the ordinance with the temporary language in it and carried 2-0.

3) Wright County is updated election equipment starting in election year of 2020.

4) A motion to renew CD #19878 for a 12-month term at .40% APR was made by Jane Hurley, 2<sup>nd</sup> by Augie Riebel and carried 2-0.

**Business from the Floor:**

- 1) Fred Bonk discussed that Chatham Township currently has no maintenance employee at this time.
- 2) Ron Boehlke discussed if we need to dust control 20<sup>th</sup> street/Estes Ave as there is no longer a construction company on the road. He asked if we should just spray 300 feet for each resident. A motion was made by Jane Hurley, 2<sup>nd</sup> by Augie Riebel to spray the dust control as needed for this year and next year do not spray unless it is paid for and carried 2-0.
- 3) Discussed the Ebert driveway issue, another site inspection will need to be performed with another visit with the resident.
- 4) Debbie Uecker will attend the Wright County Township Officer Meeting.
