MIAMI-DADE COUNTY COURTS

Administrative Order (AO) 20-04 extending the postponement of all non-emergency court proceedings, except emergency and mission-critical court matters, through Friday, April 17, 2020.

All time limits and deadlines set by judicial order and/or authorized by rule and statute applicable to: civil (including circuit and county), family, domestic violence, dependency, probate, small claims, traffic, bond forfeiture, and appellate proceedings are further suspended until the close of business day on Monday, April 20, 2020. For clarification, the suspension of time limits and deadlines began on the close of business day Friday, March 13, 2020 and is now extended through the close of business day Monday, April 20, 2020.
