- a) The Claremont Connector Hike and Bike Trail Project was discussed along with Floyd Road Bike and Hike Trail. The documents received from the city requesting an easement have been sent to the law firm for review before being accepted by the board.
- **b**) There was a suggestion to lower the annual dues back to \$250. The board still believe there is a need for a reserve and keep the annual dues at \$275.
- c) A question was asked if all homeowners are currently on their dues. The homeowners who are late in their payment have been put on a payment plan (as required by Texas state law) to become current.
- **d)** A question was asked about National Night Out. As of the meeting there is still a need for volunteers to hold this event. An email will be sent in July again asking for help. Otherwise, this event will be cancel.
- e) The wood monument board with the name of the subdivision was discussed as it is in need of painting. The board is looking into replacing this with a stone monument.
