<u>Parliamentary Procedure Workshop</u> – Casey will work with Carol Harley and the presenter to determine a schedule.

<u>San Francisco Province Meeting</u> – When information is available, Margaret will send out the information; the meeting is tentatively scheduled for March 27-29 in Menlo Park, CA.

<u>NCCW Convention Sponsorship</u> – Marcie Downs handed out the application form to the Affiliate and Deanery presidents; she reviewed the history and noted that \$1,000 would be given to each deanery by February 29 for the 100<sup>th</sup> NCCW anniversary meeting. She reviewed expenses for a national convention.

<u>Dues to NCCW</u> – Becky Hicks requested she be notified of dues payments to NCCW. Dues were due on January 1. She will be in touch if an affiliate missed the deadline.

<u>2020 DCCW Convention Update</u> – The convention is April 25-26. The packets are available and Casey handed them out to the Deanery presidents. She reviewed the contents of the packets with the group. Patricia Ramos-Yarber reviewed the service project for the convention, Bringing Comfort to Women in Need. She requested we bring items for women in shelters. A list is enclosed in the convention packet. Contact Trish is you have a specific location in mind for donations.

<u>Director of Meetings</u> – Bobbie Hunt reported on the progress she has made. For the Friday dinner expense, we are trying to keep the cost to \$30. We need at least 35 people for the meeting. Convention attendees should have access to the 10<sup>th</sup> floor "hospitality room" (presidential suite). Dietary requests need to be identified for the WOY dinner. Please let Bobbie know of the speakers' needs for Audio-Visual in advance. Vendors need to be identified for the room set-up. In February, Bobbie will contact the bus drivers for the ride to mass at the Cathedral.

Room rate - \$116 (single or double), \$126 (3 people); parking in the lot will require parking validation. The hotel meeting is on January 31 and Bobbie will follow up with the hotel staff on parking validations. Installation of officers will be set up according to Marcie's needs. Becky Hicks is working as the DOM co-chair.

<u>Registration</u> – Cheryl Johnson noted the space for dietary needs and first time attendee on the form; please use one check for registration and one check for hotel from each affiliate.

<u>Hotel</u> – Carol Harley reiterated the room rate as \$116 single/double and \$126 for triple. Please list all guests in each room. She is waiting on pricing/possibility of quad rooms.

<u>Ways and Means</u> – MaryAnne note two items for the raffle/silent auction from each affiliate; MaryAnne will determine which items go to the silent auction. MaryAnne needs to know about large items so she can plan out the space in the room. April 1 is her deadline. Please put a value on your items. Don't forget about the centerpiece for the tables for the Saturday luncheon.

<u>Convention Program</u> – Becky Colombo will solicit for advertising of previous vendors. She has provided the information for advertising in the convention packet. Annual Reports are needed; Becky will send an email reminder; the deadline is March 15.

<u>Leadership</u> – Barbara Kerouac reviewed the poster session which is in the hall; provide your own easel. The throw down challenge prize is a free package A or B for the drawing at the convention. Sponsorship is available. Contact Barbara with questions.

<u>Resolutions</u> – Jeanne is requesting we submit resolutions now. Her article in the Winter Aware can guide you through the process. Contact Jeanne if you need assistance on writing a resolution.

<u>Sponsorship</u> – Ernie Folks and Nancy Reading explained the two sheets on sponsorship for the convention. Please follow the guidelines. You can fax information to Ernie if you can't email her. The deadline is March 13. Pastors may know ladies who qualify for sponsorship. Nancy asked that we make it a goal to have someone come to the convention on our dime.

<u>Affiliate of the Year</u> – Cheryl Johnson reviewed that the criteria for the Affiliate of the Year as outlined in the convention packet. Please submit forms over the internet, not through the mail. The committee will determine first, second and third place. The winner will be announced at the convention.

<u>Convention Bags</u> – Karan Curtis noted that 150 bags are now done and more are under construction; please remember to send \$50 donations from affiliates and deaneries to Becky Hicks for the host deanery expenses. Becky will email the deaneries on January 27.

**Announcements** – Casey reminded members to watch for the convention deadlines. Fr. Rene's birthday is today and a cake was presented. Angela Martinez noted that we had a Carmelite nun who took her final vows on Sunday and we lost Sr. Cecilia this week. She thanked everyone for their contributions to the convent. Bobbie noted that Sr. Martha at GMAC is taking over for Sr. Arthur who has been transferred.
