- Received two proposals for the filter replacement. One more bid should be coming in any day. West Tech came in at \$145,000 and Korita came in at \$181,600. A motion was made by Tom Goskusky and 2nd by Mike Supan Jr. to accept the lowest bid from West Tech unless the last bid comes in lower.
- A motion was made by Mike Supan Jr. and 2nd by Dave Wiesbrock to pay Advanced Asphalt \$104,318.38 for paving several roads, pay \$12,454.59 for ditch work, grading, installing a culvert on Wequash St to alleviate erosion and to pay \$14,867.34 for cement work and the correction of the sidewalk in front of the church. The church will reimburse the Village for \$9,867.34. The Village will be paying \$5000 out of the sidewalk fund for sidewalk work at the church.
