- 5. Architectural Committee report.
- a. Walkway beam replaced due to rot. Broken concrete stairs replaced. Rotted beam and fascia boards replaced.
- b. Lights in the front have been worked on, and are working. But we still need an electrician to help with some broken bulbs in the fixtures.
 - c. door stops and light bulbs have been ordered, but not delivered yet.
 - d. garage door motherboard replaced, but still appears to be sticking.
 - e. tree trimming to be ordered for front of bldg.
- f. Parks dept trimmed trees behind the complex and installed a new fence to improve security.
 - g. Repiping update: A bid has been approved by the Board, and the homeowners will vote soon on approving the funding of the repiping project. January 28 we will hold a meeting in the Rec Room for all questions re: ballot, bid, contractors, etc. Ameri-Cal contracting will be in attendance. Somewhere ballpark \$200,000 has been spent to date over the last 3 years on plumbing repairs, and still leaks persist. Ballot due by Feb 18.
