Elections in January

As 2021 grows smaller in the rearview, all of us who have served for the past several years as your elected HOA Board will be stepping aside to make way for a newly elected and appointed Board during the upcoming January 27 General meeting. The President and Vice President, who are elected on even numbered years, will appoint a Treasurer, Corresponding Secretary, and Recoding Secretary during their first month in office at their regular Executive Board Meeting. These appointees will then be candidates for formal elections in 2023.

Who Can Vote in January?

All "active members" of NRE may cast one vote per family (regardless of lots owned) in the General Election. "Active" means those who have paid dues (\$50) for 2021. Dues for 2021 may be paid up to and at beginning of the January Meeting to be current. Voting is by secret ballot. Voting can be done early by mail if one cannot attend the January 27th meeting. In order to vote by mail the voter must address an outside envelope with proper return address including sender's name to any current NRE Officer. Inside must be a sealed envelope with the voter's choice for President and Vice President. No marking of any kind is allowed on this inside envelope in order to protect the secret ballot process. Note that those who need to vote by mail must follow this procedure exactly for their vote to be counted.

- Security Chair-works with VP to supervise/coordinate NRE security issues. Coordinates COP (Citizens on Patrol) program for community.
- Information Tech Chair-new chair that would address better coordinated use of website and social media for NRE promotion and better communications.
- Animal Chair-point person for all animal related issues including dumping, cruelty, and revised VET farm call.
