WATER MAIN REPLACEMENT **PROJECT UPDATE - PORCUPINE**

Arrowbear Park County Water District has completed the new water mains for Keater and Badger and are working on Porcupine. We anticipate completion of this section, pressure testing, disinfection, and connecting to meters in August, with paving to be done shortly thereafter. We appreciate the patience residents in the area have had during the work. Sometimes, it seems the work is going slower than normal, but, this is because we are saving the



District and residents a significant amount of money by doing the projects with our own personnel. Due to this cost saving method, there are times when leaks, regular maintenance, and meter reading take us away from the project.

Board Meeting Highlights

Regular Board Meetings are the Third Thursday at 6:30 PM

April – Supervisor Miller reported on water and sewer maintenance issues resolved in March and responded to Directors' questions regarding water testing and leaks. Chief Hall reported on the Departments calls that were run and the toilet valve leak water damage at the station. General Manager Huff reported to the Board his analysis of peak sewer flows comparing wet and dry weather months and precipitation levels as they pertained to the new Wastewater Treatment Plant Agreement. The analysis showed no significant rationale for Running Springs to change the cost methodology. He also reported on the SDRMA Safety Conference he attended. The Board discussed and then moved to vote for Kimberly Cox as a regular LAFCO Board Member. The Annual Budget Workshop was scheduled for June 7, 2016. May - Supervisor Miller reported that they were almost done with pipe laying on Keater. Chief Hall reported on the progress of the repairs at the Fire Station and updates on upcoming weed abatement inspections. General Manager

Huff reported that the number of liens on properties in the District had been reduced from 25 to 10 due to the diligence of Administrative Secretary Rimmer. The Board discussed Running Springs' new proposal to charge an \$18 per month flat fee for each EDU for wastewater treatment and what the District's options were if a new

Wastewater Treatment Plant Agreement was not in place when the current one expires in Jan 2017. The proposed master plan and related cost allocations were approved by motion.

June - Supervisor Miller reported on maintenance issues in May, beginning of the Porcupine pipeline



project, and manhole raising in preparation for sewer inspections later this year. Chief Hall reported on calls, weed abatement, and Fire Fighter I Certifications. He announced that the Annual Fire Fighter's Association Picnic will be held Saturday, July 2, 2016 at Tucker Field in Arrowbear. The Board approved the FY 2016-17 budget and several budget related motions and resolutions.

STATE WATER CONSERVATION **MANDATES UPDATE**

From the CA State Water Resources Control Board website. "Recognizing persistent yet less severe drought conditions throughout California, on May 18, 2016, the State Water Board adopted an emergency water conservation regulation that replaces the February 2 emergency regulation. The May 2016 regulation that will be in effect from June 2016 through January 2017 requires locally developed conservation standards based upon each agency's specific circumstances. It replaces the prior percentage reduction-based water conservation standard with a localized "stress test" approach. These standards require local water agencies to ensure a threeyear supply assuming three more dry years like the ones the state experienced from 2012 to 2015. Water agencies that would face shortages under three additional dry years will be required to meet a conservation standard equal to the amount of shortage." Based on the size of our District, we are not subject to the Urban Water Supplier "stress test" requirements (though we have historical data to support the needed water production in these types of dry years). As a District, we are still mandated to limit outdoor irrigation of ornamental landscapes or turf with potable water to no more than two days per week,

currently Wed. & Sat. Due to the continuation of the State's mandates, the District will keep in place the Stage 3 Water Conservation Policy. As of May 18, 2016, all residents are also required to comply with the following state conservation mandates.

NOT ALLOWED:

- (1) The application of potable water to outdoor landscapes in a manner that causes runoff such that water flows onto adjacent property, non-irrigated areas, private and public walkways, roadways, parking lots, or structures;
- (2) The use of a hose that dispenses potable water to wash a motor vehicle, except where the hose is fitted with a shut-off nozzle or device attached to it that causes it to cease dispensing water immediately when not in use;
- (3) The application of potable water to driveways and sidewalks;
- (4) The use of potable water in a fountain or other decorative water feature, except where the water is part of a recirculating system;
- (5) The application of potable water to outdoor landscapes during and within 48 hours after measurable rainfall:
