Public Participation:

- > Bid openings for the construction of phase two of the walking trail.
- Base Bids will be read only, for limestone; awards will be decided within a few days after alternatives are reviewed.

- Discussion on the financials of the township.
- Funds from Sunoco for Mountain Road overlay, Road Bond with Sunoco on Mountain Road, must repave the road but no written guarantee the funds will be forwarded to the township. Agreements held with Sunoco/Energy Transfer.
- Somerset Trust pending loan payment, option to refinancing existing loan
- ▶ Liquid Fuels 2020 Allocation and the general fund balance.
- Unwilling to accept and award the bid, if financials are not in place, the motion to accept the lowest bid would be null and void if funding is not in place. Paving season ends November 15th, 2020.
- Sunoco still using Mountain Road to haul stone back to the state game lands which will add extra demands on the road.
- Reneging on the commitments to the residents of Mountain Road and the accepting a bid without the proper financing.
- For the record –Vice President Raymond Guzic, Jr. /Roadmaster is not in favor of an overlay of Mountain Road.

Motion made by Raymond Guzic, Jr 2nd ______ to accept the both bids from NES&L, lowest bidder pending approval of solicitor, engineers review, and financing, option#1 \$84,786.75, option#2 \$55,470.60, to pave Hilltop Road. Motion failed due to lack of a second.

Vice-Chairman/ Roadmaster is not in favor of the overlay on Mountain Road, Mountain Road is in better shape than most of the dirt roads in the township, and dirt roads are a safety risk in the winter months.

Motion made Scott Guzic, 2nd Jaime Hartline to table the bids for Hilltop Road. Roll Call, Jaimeyes, Scott- yes, Raymond –no. Majority rules, motion passed.

- > The motion to table will keep the paving bids intact.
- Vice-Chairman/Roadmaster is not in favor of tabling the motion.
