The new 2020 Board officially took office on January 9, 2020 with a full agenda to kick off the year. More than 70 members attended the January meeting. The Hernando County Administrator, Jeff Rogers was the featured speaker. Commissioner Jeff Holcomb, conducted the ceremony for the new Board members. Thank all of you who came out to our first meeting of the year. We invite all North, Central, and South Hernando Beach property owners and business property owners to join the HBPOA to learn about important updates on issues affecting our community.

I'd like to give special recognition to our commercial realtors who purchased memberships for their new home buyers in January. Weaver Realty bought 12 memberships for her home buyers, and Tracie Maler with Keller Williams Realty also bought 12 new memberships for her new home buyers. All totaled, we had approximately 30 new memberships at our January 9<sup>th</sup> meeting. We encourage all realtors and business owners to join efforts to encourage our new property owners in the area to attend HBPOA meetings and become members.

At our January meeting a Bylaws Committee was formed to review and update our bylaws. Volunteers include, Fran Baird, Mike Fulford, Charles Greenwell, Barry Holland, Yann Milcendeau, Kelly Reeve, and John Paul Reeve. Their first kickoff meeting was held January 17, 2020 at the Silver Dolphin where they drafted suggested changes for consideration by the Board and the Membership. We thank them for taking time to volunteer to get our governing documents in order. The last update to our Bylaws was in May 2016. Currently some of the commercial property parcels qualify to join HBPOA while other parcels are not eligible under the current bylaws. We expect to include omitted commercial property own-

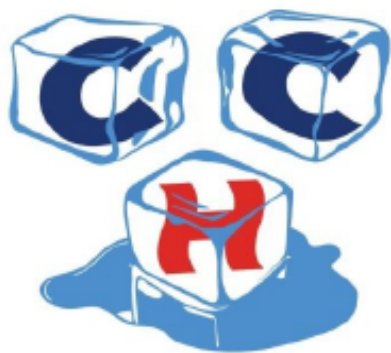

## FEBRUARY SPEAKER



Mr. Scott Herring, P.E., serves as the Hernando County Director of Public Works and as the County Engineer since December, 2017. Mr. Herring earned an Engineering Degree from Vanderbilt University, and is registered as a Professional Engineer in Florida and Georgia.

Prior to coming to Hernando County, Mr. Herring spent the previous eight years working for Nassau County, Florida, as the County Public Works Director. In that role, he provided leadership to multiple departments and divisions, delivered results for projects and programs, and prepared the budgets for four separate divisions. While he was originally hired as the Nassau County engineer in August of 2009, Mr. Herring was promoted within a year to be the county public works director in August of 2010.

Additionally, Mr. Herring has been active with various leadership associations and organizations. In 2016, he was presented with the Leadership Nassau Alumni of the Year award. He served as chair of the Technical Coordinating Committee for the North Florida Transportation Planning Organization in 2012 and 2016. He also served as President of the Florida Association of County Engineers and Road Superintendents from 2000 to 2001.

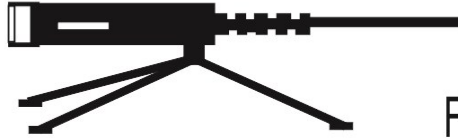

who has another year as Director of his two-year term will be installed when he returns from an extended trip. Each officer was installed individually with directors being installed as a group. The slate were all welcomed and wished well.

At this juncture, Diane Greenwell, New President, took the gavel and began her first meeting in her new capacity by inviting Kathy Frase to say any parting words. Kathy had words of encouragement and support for the 2020 board and expressed her gratitude for the support she has received for the past two years as President of HBPOA. She also thanked Mr. Holcomb for having taken time from his busy schedule to conduct our installation.

Diane's first order of business was to introduce Mike Fulford who in turn introduced our guest speaker, Jeff Rogers, Hernando County Administrator. His presentation was primarily divided into 6 topics:

1) Weeki Wachee River.....He spoke at some length about the River, covering such issues as the ongoing Carrying Capacity Study (PIW to be held on 2/5/20 at Coast Guard Building at 5:30 PM) and also how the river is being harmed by over usage and improper usage. He addressed the Channel Restoration Project and also mentioned some ongoing projects involving the HB Boat Ramp, parking at the Beach, and the Bayport Pier, to name a few.

2) Hernando County Fire Rescue.....Mr. Rogers gave us an update on the planned remodeling of our Fire Department which should start during the second half of this year.

3) The Restore Act.....He presented several charts

demonstrating how portions of the money that Hernando County is finally receiving from the BP oil spill will be spent among various projects here in Hernando Beach.

4) County Budget....Slides demonstrating the elements and allocation of the budget for HC were presented; furthermore, Jeff reassured us that his goal will be to end up the year with a balanced budget, unlike that of 2019.

5) Future Land Use Map (FLUM).... A committee is being formed by BOCC utilizing business leaders for input re future development with an eye towards redrawing the Land Use Map, obviously with a potentially major effect on residents of Hernando County.

6) BOCC Directives....A number of issues that could affect us directly/indirectly and the progress that is ongoing for each were enumerated on the last slide.

These were the highlights of his talk although he addressed some other pertinent issues as well and took questions from the floor on various subjects. Attending the monthly meetings definitely affords residents the opportunity to truly become informed about things important to our community!

Following Mr. Rogers' presentation, Mike Fulford outlined upcoming speakers for the next two meetings and mentioned some ideas even beyond that. He invited any member who has an idea for a topic of interest to the community to private message him on Nextdoor.

1) Diane thanked all attendees for coming out tonight and expressed how important it is for attendance and participation in our organization.

2) She canvassed the group on whether they appreciated having the agenda ahead of time and it seemed that most in attendance did indeed.

3) Diane invited first time members present to stand and introduce themselves. It was extremely gratifying to see quite a large number of new households, 8 tonight alone. Margaret Weaver and Tracy Mahler were mentioned and thanked as two realtors who are very proactive in promoting HBPOA membership to new homeowners.

4) She asked that if anyone at any meeting wishes to make a motion, he/she stands and states his/her name clearly for the record.

5) Our President explained that beginning with our next meeting, members only will be provided an opportunity to raise any issue of interest or importance for the consideration of the Board and general membership.

6) Diane announced that the Board is very desirous of having commercial business property owners be-

come an active part of HBPOA so that we can grow strength in numbers and know that we are working together for our community. Gladys Moore, who has lived here for many years and has been an active participant in many organizations and was a realtor, was asked to explain how that our By-Laws specify a portion of commercial (and even some residential) properties that are eligible to join HBPOA while others were omitted. She explained that this information is available for anyone who wants it and Diane further explained that we are committed to revising the By-Laws to include those properties since the current ones related to this issue are unfair.

7) Diane explained that a copy of our Vision Plan (done several years ago by canvassing the residents soliciting their opinions on how they wanted HB to be regarding future development). This is going to be presented to the County very soon so that our ideas might be incorporated into their future development plans so that we aren't fighting the same battles time and time again. She emphasized that nothing is set in concrete and encouraged anyone interested in learning more about the Plan to take a few minutes to look at the plans and to get involved with the process.

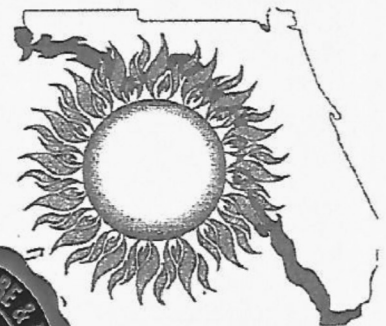

cation and salesmanship for the sale of shirts and hats which has resulted in their being sold out except for a very few hats and really large shirts.

6) Environmental/Water Update.....David Snutes has become involved with "Lakewatch" in Gainesville, which is a program at the University of Florida which has existed a long time and began because of the desire of Lake Santa Fe residents to protect their lake. David has taken it upon himself to collect water samples from the mouth of four snapper channels, sending them to the Department of Environmental Protection for testing (no results yet). He made the point that all of us are contributing to the degradation of our waters in various ways with irrigation, fertilizers, lawn spraying, etc., and it is imperative that we become much more proactive in protecting our waters. There seemed to be some real interest in some of these environmental issues and Diane suggested that interested people sign up to be on such a committee and see where it may take us.

7) LMS Update.....Chuck Greenwell is on a committee for Hernando County for Local Mitigation Strategy, which is especially important in Hernando Beach, obviously a high risk area for damage from hurricanes and other storms, all of which can lead to storm surges.

## Horseshoe Crab Watch

**A Citizen Science Program**

We need data to better understand horseshoe crab populations throughout Florida! Want to join our team of volunteers? The UF/IFAS Extension Office will be holding a training workshop on March 23, 2020.

Launched in 2018, UF/IFAS volunteers in Hernando County survey coastal shorelines for mating horseshoe crabs on specific days during the spring and fall. Information gathered from this program allows scientists to track horseshoe crab movements, estimate population sizes, and understand mating patterns.

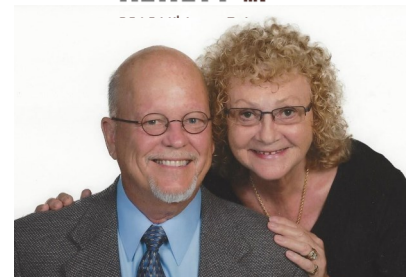
