Mutual has arranged for a \$50 discount when you access your training via Sales Professional Access (SPA) www.mutualofomaha.com/broker.

Upon successful completion of the AHIP Certification, you may have your results submitted electronically to Mutual of Omaha. No need to Fax or mail your certificate. If you have completed the assessment using another carrier, no problem. You can still have your results transmitted to us by clicking through the SPA link. You will not have to pay or take the assessment again. You will find instructions on the AHIP page.

If you are currently contracted for Medicare Advantage through Mutual of Omaha Medicare Advantage Company (MOMAC), a Medicare Advantage Insurance Company of Omaha (MAICO) Amendment will be required if you are planning to sell outside the current MOMAC markets. This new company is for Medicare Advantage plans rolling out this year in the following markets: Denver, Dallas/Fort Worth and El Paso.
