### PENTWATER SPORTFISHING ASSOCIATION BOARD MEETING

## September 25, 2022

#### PENTWATER VILLAGE PARK PLACE

Directors Present: Dean Jessup, Bruce Koorndyk (past president), Patsy Gettings, Dan Gettings, Steve Sauser, Rob Bannink, David Vanderveen. Absent: Cody Anscombe.

Meeting called to order at 2:07 p.m. by President Dean Jessup.

- A. The Meeting Minutes from the August 28, 2022 Board Meeting were reviewed. Steve S. moved to approve the minutes as submitted, seconded by Patsy G. Motion carried unanimously.
- B. Treasurer's Report: Patsy G. handed out and reviewed the report. The PSA continues to maintain a strong checkbook balance. A note was made to show the \$450 collected in memory of Jerry Daggett as a separate account, and Patsy will update the report accordingly. The PSA is working with the Daggett family to determine how to use these funds. Dan G. moved, seconded by Bruce K., to accept the Treasurer's Report with the above update. Motion carried unanimously.
- C. A motion was made by Patsy G. that the Treasurer's report presented at the September PSA Board Meeting will be considered the year-end report. Any funds received or expenditures made after the September board meeting will be applied to the following year (2023 in this case). Motion seconded by Steve S. and carried unanimously.

#### **Old Business:**

- A. Dan Gettings presented an updated clothing inventory. PSA has a good inventory of most items, and Dan will replenish the inventory of other items as needed. Dan will also look into some new items to add to the inventory and will present options at the next PSA board meeting.
- B. Rob B. provided an update on the Bannink's Lines Down Tournament. The tournament had to be cancelled due to weather. The majority of the people who entered donated their entry fees to PSA, resulting in \$455 donated to the PSA general fund.
- C. Dean J. reported that he received the plagues for the PSA Big Fish contact and will pass them along to the winners. Total cost for the plaques was \$238.55.
- D. Dean J. reviewed the PSA Annual meeting with 20 attending. Food Cost was \$74.15. Big Fish Awards were presented with a thanks to Win and Bette Matteson for supporting this annual contest.

#### PENTWATER SPORTFISHING ASSOCIATION BOARD MEETING - Continued

#### **New Business:**

- A. Dean J. presented the "2022 Year In Review" (see attached).
- B. Dean presented the draft 2023 Schedule of Events. A proposal was made to change the May board meeting from May 20 to May 6. Steve S. made a motion, seconded by Patsy G., to approve the Schedule of Events with the change of the May meeting to May 6. Motion carried unanimously. The approved 2023 Schedule of Events is attached.
- C. Dean J. reported that the PSA currently has a balance of \$995 in the Fish Cleaning Station fund. Patsy G. made a motion, seconded by Rob B. to add \$5 from the General Fund to the Fish Cleaning Station fund, and make a donation of \$1,000 to the Village of Pentwater to support the Fish Cleaning Station. Motion carried unanimously. Bruce K. will present the check to the Village at the October 10, 2022 Village meeting.
- D. Dean J. proposed standardizing certain rules for all PSA tournaments, derbies and annual contests. The proposal is as follows:
- E. BOUNDARY WATERS: North end Consumers Project, (N 43-54-45) to 2 Miles South of Little Sable lighthouse (N 43-37-00) and Pentwater Lake to Longbridge Road.
- F. Boats must leave from and return to Pentwater Harbor daily.
- G. All fish must be caught from a boat.
- H. Steve S. made a motion, seconded by Rob B. to approve the above rules for all PSA tournaments, derbies and annual contests. Motion carried unanimously.
- I. Steve S. made a motion, seconded by Rob B., to establish a 3-person event committee for the Memorial Weekend Derby, mini-tournaments, Teach-a-Kid event, and Banninks' Lines Down Tournament. The committee will make and communicate decisions on weather-related event cancellation or re-scheduling. The timing and method of communication of any cancellation/re-scheduling will be published in the rules of each event. Motion carried unanimously.
- J. Dean presented the 2023 Officers/Directors List along with 2023 Committee Appointments. See attached.
- K. Dean J. opened a discussion on the 2023 Memorial Weekend Derby. The event will function as in the past with key donor contacts to be made early 2023. Dean will coordinate the registration and tickets for the raffle. Sportsmen Charters will once again provide the 1st Place Prize of a charter fishing trip, with PSA covering the fuel cost.
- L. In 2022 the PSA printed 1,000 raffle tickets and sold 3 tickets for \$5. Bruce K. made a motion, seconded by David V., to print 500 tickets and sell them at 1 ticket for \$5. Motion carried 4 to 3.

#### New Business continued.....

- Dean J. provided an update on the Michigan DNR's plans for Chinook stocking. Starting in 2023 the DNR is proposing to increase Chinook plants from 654,306 to 1,000,000 per year.
- Dean J. reported that he will be representing the PSA at the Lake Michigan Citizen's Fishery Advisory Committee Meeting on September 29.
- Patsy G. moved to adjourn the meeting, seconded by Rob B. Motion carried unanimously and the meeting was adjourned at 4:39 pm.

# Pentwater Sportfishing Association 2022 - Year In Review



- May 28 30 Memorial Weekend Derby 35 Boats entered with \$6000+ prize package. Grand Prize to 'Afternoon Delight' Boat, Capt. DeWayne Samuels with a 25.4# King. Rick Miotke again donated the Grand Prize Steelhead Carving.
- June 25 PSA Mini Tournament 7 Boats entered with 5 weighing fish, with total weight of 117.15 lbs. Producer Fishing Team won 1st Place with an 18.4# King, 2nd Place of Most Fish won by Breakaway Team, and Mystery weight was won my Lym Time Team.
- July 30 Ladies Classic Event 16 Boats Entered with 398.22 #'s of Fish weighed. Big Fish was 24.15# King on 'Trips to Win" Boat with Captainette Stacy Daggett. 2nd Place of Most Fish on 'Pentwater Haze', Captainette Sue Czajkowski, (6 fish weighing 67.67#), and Mystery Weight won by 'Inn Pursuit', Captainette Sherry Smith.
- August 6 Teach-A-Kid Event 8 Boats with 17 Kids entered and weighed in a total of 189# of fish Big Fish was a 26.75# King on board with George Cornell, 'Reel Dancer' Boat. The Ludington Meijer Store was key sponsor for the event.
- July / Aug 2 Boater Safety Classes Officer Tim Simon held, but a change to only DNR registration via web.
- August 20 PSA Super Mini Tournament 21 Boats Entered 'Farmer' boat of John Cunningham won with Big Fish (30.25# King), David Vanderveen
  on 'Breakaway' won Most Fish (10) and Mike Havens, Big Foot Boat, won mystery
  weight. 97 fish weighed in, with total weight of 1321.6 lbs. !!
- September 3 Bannink's Lines Down Weather conditions did not cooperate and the event was canceled.
