Possible action regarding Rim Village HOA request for use of culinary water for outdoor irrigation including rates and length of time – Duane Stewart, HOA Manager Duane explained that when Dana asked him to switch to culinary water before work on the pumps was completed that Rim Village was required to replace their existing backflow protection devices. The cost was roughly \$5k. Dana and Duane had a misunderstanding that he was going to be permitted to use culinary water up to their 50% at no cost even when the wells were online. The misunderstanding was rectified on September 4<sup>th</sup>. The board discussed options and advised Duane that he could switch back to irrigation water at any time. Motion to waive water fees up to September 4, 2018 by Mike Holyoak. Second by Ken Helfenbein. MOTION CARRIED 7-0.

Financial Statement the August 2018 Financial Statement was presented.

<u>Lake/Snow report – the lake is at 156 AF, SWE is 0% of average and Precipitation is 57% of average. Soil moisture is at 6%.</u>

<u>Items from staff</u> Water project plans to open bids 10/18/18. Dana attended the MIC meeting on 9/19/18 to discuss the drought and any possible increase in MIC pricing. They do not anticipate an increase. A new truck is ordered and should be here in approximately 10 weeks. There was a sewer overflow on Shumway Lane on Sunday night that looks to be caused by vandals. Some of the flow made it to the creek, and that was reported to the state by Dana on Monday morning. The board directed Dana to report the vandalism to the Sheriff.
