

Calling one and all! We are so excited to announce that The City of Irvine has graciously agreed to allow us to use their entire Lakeview Senior Center for our all day Conference! Our theme is all about Safety!!!

Recently we have been hearing from providers that they have had people contacting their facility for interviews seeking positions as assistants or looking for child care and the people calling and at times coming to interview made the providers feel unsafe and uncomfortable. On some occasions providers took their children on field trips and encountered strangers making them uneasy. So we contacted **Yousef Badou** who is a **Personal Security Specialist** and asked him to create a situational awareness workshop that fits the needs of a Family Child Care Provider and he agreed to come and present that program as our Keynote Speaker. Yousef is a former Marine and currently trains Law Enforcement Agencies and Military personnel on how to stay protected and safe through situational awareness. I have been through his workshop and it is a MUST SEE. Please feel free to bring your assistants and spouses. We cannot allow young children at this conference HOWEVER if your child is over 14 which is the legal age for an assistant in your facility you can purchase a ticket for them as well.

We received some calls regarding food poisoning and allergic reactions to certain foods that have some providers concerned so we contacted **La Habra Food Program** and asked them to present at our Conference as well. They will be presenting a hands on workshop on how to make **Delicious and Healthy Snacks in a Safe Environment**. This workshop will be in ENGLISH and SPANISH.

In this technological world we live in children are falling victim to living a sedentary life attached to iPads, video games, cellphones and televisions. Gone are the days of getting out into the sun and playing and using their imaginations to go on adventures that help them to grow emotionally and giving them a healthy mind and body. **Pat Nelson** from **Discovery Toys** will be presenting **Crisis in Play - the downside of technology**.

We were really surprised to hear that many Providers conduct their businesses without a contract! **Vickie Rossiter** has agreed to come back and present her workshop on **"Contracts"**. She brings a vast wealth of experience as a Family Child Care Provider, OCCCA Board Member, OCCCA Area Chairperson for the City of Irvine to our Conference. As a business owner you should not go another day without a Contract that keeps you safe.

Disaster Preparedness is or should be on everyones mind. With the recent rainy weather emergencies in California, there were times that parents could not get to their children due to flooding and/or weather emergencies. We had some power outages that lasted for hours at a time and phones went out, all during business hours. We received calls from providers that did not know what to do. **Eric Allton** who is a Safety Coordinator at **University California Irvine** will be presenting what exactly should be done should we be faced with this again, joining him will be **Stan Rook** from **My School Insurance**. Stan will go over what insurance companies require from Family Child Care Providers to obtain insurance and how to protect yourself as a provider should you get ill or injured or if there is damage during weather episodes and you are not able to work.

Have you ever attended a Child Care Conference? If you haven't they can be so beneficial in so many ways.

First of all, to find a list of conferences for 2017, simply Google “Child Care Conferences”, or “Early Childhood Education Conferences”. There are several lists that are put out annually of National Conferences, as well as smaller local conferences.

If you have never been to a National Conference, and you are a dedicated provider, you need to make the time and effort to attend. Some of the National Conferences move around the country. You have a good chance of finding one in an area you have always wanted to visit, or vacation. By going to a conference in a vacation state, you still get to deduct most of your trip as business expenses on your income tax, so you will see some return on your expenses. (PLEASE always check with your tax advisor first.) Next time you are going out of state, or even within the state to visit family or friends, see if there is a conference. You can spend a day, or a couple of hours. National Conferences are general 3 sometimes 4 days. If you go with a friend, you even get to split some of the expenses. Now, in addition to being tax deductible, if you choose a National Conference, the Vendor Room is pretty awesome. The bigger the conference, the more representation is there. You will see new products, new gizmo's, and great products for the Provider to make her job and life a bit easier and fun. Speakers are fun, exciting and motivating. Guaranteed you will come away recharged and energized. You will meet some new providers from other states, and share ideas. You will be surprised at how different child care is from state to state. I have always come away with new ideas for my contract, or a new policy I had never considered. You just don't know what you don't know.

Some of my best memories are of attending out of state conference's with other child care providers who turned into lifelong friends.

Public Policy Updates

AB 603, as introduced, Quirk-Silva. Child care: alternative payment programs: child care providers. The Child Care and Development Services Act, administered by the State Department of Education, requires the Superintendent of Public Instruction to administer child care and development programs that offer a full range of services to eligible children from infancy to 13 years of age, inclusive. The act requires the department to contract with local contracting agencies to provide for alternative payment programs, and authorizes alternative payments to be made for child care services, as provided. The act requires child care providers authorized to provide services to submit to the alternative payment program a monthly attendance record or invoice for each child who received services, as provided. Existing law requires alternative payment programs to reimburse licensed child care providers in accordance with a biennial market rate survey, as provided.

This bill would require, on or before January 1, 2019, alternative payment programs to develop an electronic time sheet process for the monthly attendance record or invoices, as provided. The bill would require, beginning January 2, 2019, alternative payment programs to offer the electronic time sheet process to child care providers. The bill would require, beginning January 1, 2019, alternative payment programs to offer to reimburse the child care provider via a direct deposit transfer into the child care provider's financial institution account. The bill would require, beginning July 1, 2018, alternative payment programs to provide written notice to a child care provider of any changes to service, as provided.

Buckle up - California Highway Patrol

Effective January 1, 2017: Children under 2 years of age shall ride in a rear-facing car seat unless the child weighs 40 or more pounds OR is 40 or more inches tall. The child shall be secured in a manner that complies with the height and weight limits specified by the manufacturer of the car seat.

Current California Law: Children under the age of 8 must be secured in a car seat or booster seat in the back seat. Children who are 8 years of age or have reached 4'9" in height must be secured by a safety belt. Passengers who are 16 years of age and over are subject to California's Mandatory Seat Belt law.

Mandated Reporting- Assembly Bill 1207

Beginning on January 1, 2018, this law requires that all licensed providers, applicants, directors and employees to complete training as specified on their mandated reporter duties and to renew their training every two years. Volunteers are encouraged but not required to take the training. A second paper plate (with the middle cut out) glued on to the first was needed to make it strong enough to hold up.

Since the election bullying is on the rise. Here is a list of books to help a child grow empathy instead of anger.

- 1. THE DAY THE CRAYONS QUIT: This book is about personal limits and listening to both words and nonverbal cues.*
- 2. BEAUTIFUL OOPS: This book teaches that mistakes are OK and that sometimes beautiful things can come of them.*
- 3. INSIDE OUT & BACK AGAIN: This book covers emotions ranging from grief to resilience. It's about a little girl who has to leave her beloved home because of war and move to Alabama.*
- 4. WONDER: This book is for older children. It's about seeing beyond the surface--with our heart instead of our eyes.*
- 5. BROWN GIRL DREAMING: This is a memoir about an African American girl who grew up in the '60s and '70s. It's about everyone's wish to belong.*
- 6. THE ONE AND ONLY IVAN: This book is about personal accountability and our responsibility to help make change happen by using our personal gifts and strengths.*
- 7. THE STORY OF FERDINAND: This is a story about a mother accepting her child as he is, even though he is quite different from the others.*
- 8. THE INVISIBLE BOY: This is a book about friendships and feeling like you are noticed.*
- 9. THE GIVING TREE: This is about a tree who loves a little boy so much that she gives everything she has to give.*
- 10. A CHAIR FOR MY MOTHER: This is a story about a family who loses everything in a fire and struggles to save coins so that they can buy a comfortable chair, even though they have been given replacement furniture from friends and family.*
- 11. BABY BE KIND: This book teaches little ones how to be kind by giving examples and using simple language and cute pictures.*
