STANDARD CRITERIA FOR TENANT SELECTION

- Verification of consistent employment and income of at least 3 continuous years.
- Verification of valid and verifiable positive, current rental history / or residency history for the last 3 years.
- Positive credit history and credit score above 650. (Minimum of 1 year responsible credit use and current payments)

Criteria that will result in denial of application and residency for all applicants include:

- History of criminal activity. (Arrests and / or convictions, violent crimes, felonies, misdemeanors, etc. by any occupant)
- Evictions, negative rental history or un-verifiable rental / residency history on any applicant's record.
- Negative credit issues which may indicate applicant is high-risk, a pattern of payment delinquency and or a credit score below 650.
- Excessive debt which may impact applicant's ability to pay rent.
- Omission or falsification of any information, incomplete applications and or failure to provide requested information and or documentation within 24 hours.
