Wyckoff Police Chief David V. Murphy announced today the arrests of Davon H. McSwain, Newark NJ age; 22; Eshonda F. Jones, East Orange NJ, age; 23; Eyrikah J. Jones, Newark NJ age; 20; Terrance R. Richardson Newark NJ age; 25; and Asalik M. Bronson, Newark NJ, age; 33.

On November 16, 2017 at approximately 3:40 AM, a resident called 911 to report two suspicious occupied vehicles in front of his home. He also reported that an occupant from one of the vehicles had walked up his driveway and approached one of his vehicles. The caller confronted the person causing him to flee back to the vehicle and both vehicles fled the area. The caller described the vehicles as an older Buick LeSabre and a Chevrolet Corvette. Sgt. Michael Demaio responded to the scene along with P.O. Ryan Tenney, P.O. Kenneth Marcoux, and P.O. William Christopher. Sgt. Demaio observed the Buick leaving the area and conducted a traffic stop. P.O. Marcoux observed the Corvette fleeing the area at a high rate of speed and in a reckless manner, and chose not to pursue the vehicle. The subsequent investigation resulted in the arrest of the four occupants of the Buick. They were all charged with theft of moveable property, burglary to auto, possession of burglary tools, two counts each of receiving stolen property, and possession of marijuana under 50 grams. Richardson was additionally charged with providing false information to a law enforcement officer. Approximately 10 minutes after P.O. Marcoux observed the Corvette, the vehicle was stopped by the Port Authority of NY and NJ Police Department at the Port Authority Bus Terminal in NYC. The Corvette had been reported stolen from a Ringwood, NJ residence earlier in the evening. The driver of the vehicle, identified as Bronson, was taken into custody. He is being charged by this agency with the same crimes as the occupants of the Buick. He is additionally being charged with criminal trespass. He is currently being held by the Port Authority Police Department, who also will be filing charges against him.

Under NJ Bail Reform Guidelines Richardson was remanded to the Bergen County Jail, the other defendants were released from custody and are scheduled to appear in court.

Det. Sgt. Michael Ragucci and Det. Sgt. Kevin Kasak assisted with the investigation and arrest.
