RESOLUTION NO. 2016 – 15-16

A RESOLUTION OF THE HARVEY PARK DISTRICT, COOK COUNTY, ILLINOIS DETERMINING THE ESTIMATE OF TAXES TO BE LEVIED FOR YEAR 2016 IN ACCORDANCE WITH THE TRUTH IN TAXATION LAW

WHEREAS, the Board of Park District Commissioners of the Harvey Park District, Cook County, Illinois (the "Park District") is charged with the responsibility of determining the estimated amount of money to be levied in 2016 and extended in 2017; and

WHEREAS, the Truth in Taxation Law requires not less than 20 days prior to the adoption of a tax levy ordinance that each taxing district determine the amounts of money estimated to be raised by taxation for that year upon taxable property in its corporate boundary.

NOW, THEREFORE, BE IT RESOLVED by the President and Board of Park District Commissioners of the Harvey Park District, Cook County, Illinois, as follows:

- **Section 1.** That the above recitals and findings are found to be true and correct and are hereby incorporated herein and made a part hereof, as if fully set forth in its entirety.
- **Section 2.** The amounts of money estimated to be necessary to be raised by taxation pursuant to the proposed levy of the Park District for the levy year 2016 is \$1,616,200.00.
- **Section 3**. The notice of the time and place of a public hearing, if required, on the intent to adopt the aggregate tax levy for the 2016 tax year shall be prepared and published in the newspaper of general circulation published within the Park District not more than 14 days nor less than 7 days before the date of the public hearing in the form and manner provided by law.
- **Section 4**. If any section, paragraph, clause or provision of this Resolution shall be held invalid, the invalidity thereof shall not affect any other provision of this Resolution.
- Section 5. All ordinances, resolutions, motions or orders in conflict with this Resolution are hereby repealed to the extent of such conflict.

Section 6. This Resolution shall be in full force and effect upon its passage, approval and publication as provided by law.
