**New Business:**

1) The Marysville Town Board certified the 2019 Town Levy at \$300,000.00, with \$56,968.00 for general funds, \$227,872.00 for Road and Bridge fund and \$15,160.00 for debt service. A motion was made by Jane Hurley, 2<sup>nd</sup> by Joe Hickman to leave the levy the same as voted upon in March 2018. Motion Carried 3-0.

2) A motion was made by Jane Hurley, 2<sup>nd</sup> by Joe Hickman to redeem CD# 19945 for \$11,417.23 and deposit it into the checking. Motion Carried 3-0.

**Business from the Floor:**

1) Questions were raised if wild cucumbers are on the noxious weed list, after discussion they are not on the noxious weed list.

2) Bob Casey was introduced to the residents at the meeting. Bob started on August 20<sup>th</sup>, 2018 as a full time road maintenance employee.
