- ➤ Ordinance 2012-1 Flood Plain Ordinance/ Inter-Municipal Maintenance Ordinance for participation with the Cambria County Building Codes Enforcement Agency BDA: Laurel Municipal Inspection Agency. Washington Township has named the Codes office as the flood plain administrator, Inter-Municipal Maintenance Ordinance is required by the codes officials.
