FEATHERS IN THE WIND

Up until the late 1920's the Amana Church Liebesmahl (communion) was quite an elaborate ceremony.

The congregation was divided into four groups. The first or youngest group were given communion at their town meeting house (remember there were small meeting places throughout each village for nightly evening prayer).

The children were given hot chocolate along with bread and the usual songs and prayers were said.

The next week the middle church from all seven villages would assemble in Der große Saal (big hall) in Amana for Liebesmahl.

This was an all day occasion so the people would come via wagons from the farms and be issued "tickets" for an afternoon dinner at one of the 15 communal kitchens.

In the morning, the usual service would be held, but then a select few would put on special white aprons and get water to put in the special tubs to wash the congregates feet. A large set of sheets would be put in between the men and women for modesty's sake.

To wash a member's feet was considered an honor. The elders would get on their knees and wash one another's feet as a sign of humility as Christ had done to his disciples.

There would be hymns and prayers and then everyone adjourned to eat their noon meal.

Meanwhile, in Der große Saal much activity took place as the walls dividing the main Saal from the two smaller Vorsaal (fore hall) were taken down and sawhorses from upstairs were brought down.

A diagram had been made long before where all the "tables" would be placed so with sawhorses serving as table legs and wall panels as tops, tables were constructed.

The benches were placed beside the tables and special white linen clothes used only for this occasion.

General Election is November 8

The general election is Tuesday, November 8. A notice of election and a sample ballot have been posted on the Iowa County, Iowa website.

This election will decide one Iowa US Senate seat, the Iowa US District 1 seat, our Iowa Governor, Secretary of State, State Auditor, Iowa County Supervisors, County Treasurer, Record, County Attorney, Soil and Water, Iowa County Extension, various other county posts and state elected judges.

Voters must vote in their precinct of residence. Polling places will be open 7 a.m. until 8 p.m. For a complete list of all Iowa County polling precincts places go to the Iowa County, Iowa website.

Here are the polling places for Amana Colony and colony area residents:

Lenox/ Iowa townships – Middle Amana Fire Station.

Hilton/ Washington townships – Hilton Township Hall in Conroy.

Pilot/ Troy/ York – Williamsburg Recreation Center, Williamsburg.

Honey Creek/ Marengo Rural – Marengo Public Library, Marengo.

Registered voters are required to provide an approved form of identification at the polling place before receiving and casting a regular ballot, according to Brandy Enochson, Iowa County Auditor. Her office released this information: Voters who are not registered – such as voters registering to vote on election day – and voters changing precincts must also provide proof of residence. A voter who is unable to provide an approved form of identification (or prove residence if required) 1) may have the voter's identity/residence attested to by another registered voter in the precinct, 2) prove identity and residence using Election Day Registration documents, or 3) cast a provisional ballot and provide

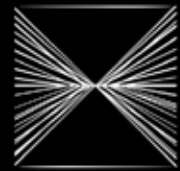

sion were spread across the table.

Wine (only the best from the past year) was brought in from the cellar below along with the "special" wine goblets and black trays for the bread which the local bakers had spent hours baking.

The congregation again assembled and partook of communion.

How they knew which table to sit at is lost to time.

After all was done everyone would clean up and go home only to have the same ceremony repeated a week or two later for the older congregation.


In the early years, communion or Liebesmahl was not held on a yearly basis, but only when the Werkzeug decided the community was "worthy" to receive it. Later it was held every two years.

It was for that reason that in 1928 Liebesmahl was suspended. It did not resume until 1952.

The all day service was suspended and so was the foot washing and sitting around the tables.

So time passes and one recalls these memories, but the most important thing we have to remember is not the rituals, but the meaning of it all. Christ gave himself for us.

MY AMANA EXPERIENCE

For this column, I was able to visit a part of Amana Society, Inc. that I have been curious about for some time - the anaerobic digester. I joined a group of local high school students, and led by Colin Strickland, Anaerobic Digester Manager, we learned how cows help keep the lights on here in Amana.

You might think, as I did, that the process of creating electricity is extremely complicated and requires diagrams and math with letters. This system is straightforward, green, and easily explained, even by me.

It all starts with manure of course.


The digester is located next to the feedlot, where the cattle are housed in an open barn with a slatted floor (the better for manure to be collected). The raw ingredients are pumped to the digester where micro bacteria "digest" them until the methane gas rises to the top. It then travels up a pipe into the engine room where it powers combustion engines to make electricity. The power is transferred to the electrical grid, and we can all microwave our popcorn.

The digester itself is a six sided, 16-foot deep, fully enclosed cement tank with eight mixers to ensure the solids sink to the bottom and the methane rises to the top. After the methane is harvested, the solids, which are now a rich fertilizer, are pumped from the digester to an 18,000-square-foot lagoon to await application to the fields. The process takes a month, start to finish.

The entire operation is run by Colin Strickland and Bobby Kruse, 365 days a year. For many years prior to this Scottie Clubb was in charge of the digester. If you happen to see any of them, you may want to thank them (and the cows) for keeping the lights on.

In office absentee ballot voting is happening now until November 7, 2022 from 8:00 AM to 4:30 PM. in the Iowa County Auditor's Office. Also, the Iowa County Auditor's Office will be open for in-office absentee voting on Saturday November 5, 2022 from 9 a.m. to 5:00 p.m.

Pension Poaching

Have you received a suspicious call from an organization claiming to represent or have affiliation with the Dept of Veteran Affairs (VA)? Did the caller guarantee a lucrative payout for your disability compensation or pension claim for a "small fee"?

Recently, VA has seen an increase of fraudsters and non-accredited representatives who are targeting the pension benefits of elderly Veterans and their dependents and survivors.

Pension Poaching is the financial exploitation by an advisor who profits by artificially qualifying a claimant for VA pension benefits. The scheme often involves financial maneuvers such as hiding assets in trusts or annuity products sometimes resulting in lost investments and lucrative fees paid to the advisor.

To avoid being a victim of fraud:

- Be suspicious if someone offers to shift your assets to qualify for VA pension.
- NEVER share eBenefits, VA.GOV, or other VA login credentials with anyone.
- DO NOT deposit VA benefits directly into a third-party bank account unless the person is court appointed or a VA accredited fiduciary.
- Remember, VA does not charge for processing a claim or request a processing fee. Use VA accredited organizations to help file your claim.
- VA does not threaten or take adverse actions such as jail or lawsuits on claimants. If in doubt, call VA directly at 1-800-827-1000.

To report suspected activity, please contact the VA Office of Inspector General (OIG) by calling 1-800-488-8244. You may also file a complaint with the Federal Trade Commission by visiting www.consumercomplaints.fcc.gov.
