## 4 **General Show Info**

**Entries:** Entries will be accepted for sixty-five riders. Others will be waitlisted. Secretary will notify you once your entry has been accepted.

**Schooling Day:** Sept 28th: Schooling is available at \$30.00 per horse and open from 2-7pm.

**Show Day:** Sept 29th: Rings will open at 7:30am. No riding will be available in the show rings in the morning. Hand walking is available 30 min prior to show time. Schooling on day of the show is available at \$50.00 per horse if you have not entered two or more classes.

No classes can be added the day of the show.

**RPHSA Membership:** An \$8.00 Non-Member Fee will apply to all those not signed up for RPHSA.

### **Stabling Options:**

Saturday day/overnight (**NO** schooling) and Sunday day: \$85.00.

**IF** you are schooling on Saturday add \$30.00 (Total \$115.00)

Sunday ONLY stall: \$60.00

Shavings \$9.00/bag

Horses can arrive after 2:00pm on Sept 28th and no later than 6pm.

No refunds after closing date.

**Awards:** Show themed Ribbons first through sixth place.

Six high percentage awards: Intro Jr & Adult, Training Jr & Adult, Upper level Jr & Adult.

Client hereby releases, waives, and forever discharges Carriage House of all actions of whatever kind or nature either in law or in equity arising from or by reason of any bodily injury or personal injuries known or unknown, death, or property damage – including damage to Client's horse and other personal property – resulting during Client's presence on Carriage House's premises and any activity involving Carriage House's services so long as such injury, property damage, or death is not caused by an intentional, willful, or wanton act or omission of Carriage House (i.e. Client releases Carriage House from liability for damages caused by Carriage House's negligence only). Client assumes full responsibility for the risk of bodily injury, death, or property damage from such activities, and shall hold Carriage House harmless for any liability thereof as set forth herein. Client further agrees that if a claim or lawsuit is made against Carriage House or its owners, members, agents, and/or employees for any injury or damage brought by, or allegedly attributable to, Client arising from Client's presence on Carriage House's premises or any activity involving Carriage House's services, Client will pay all attorney's fees and costs reasonably incurred by Carriage House to defend that claim or lawsuit and will reimburse Carriage House for any judgment, expense, or other damage incurred.
