INSURANCE

I We understand that insurance for any equipment rented from HAMMERCO is OUR responsibility.

bWe agree to pay to HAMMERCO within 30 days full replacement value of any loss which may occur regardless of the nature of such loss, whether insured or not

LWe agree at the time of such loss to file the necessary police reports, insurance claims, etc., and to immediately advise HAMMERCO as to the disposition of the same together with the name of our insurance carrier, address, policy number, etc.

L'We agree that we are responsible, even though insured, for any amount not paid by our insurance carrier, including but not limited to such things as deductibles, depreciation, or any other amount which might be denied by our insurance carrier up to and including the full replacement value of the equipment.
