Main item for the Work Day this Saturday is the work on replacing the ballistic sheets for the Indoor Range. Any help that can be provided by the members is wanted. The sheets are heavy and we need as many people as possible to get them mounted and installed.

Dan Charles brought up that the Range Flag, the flag used to indicate that people are on the range, has been shot. When the Range Flag is posted, no firearms are to be used on the range until the range has been verified clear of people by walking the range. In some areas, the people cutting grass cannot be seen from the firing line. Any incident in which people are hurt can have repercussions beyond the incident itself. Insurance companies have very little tolerance for incidents at gun ranges.

Before hunting on club property, make sure you sign in the log book. This lets people know there is someone on the property. If you don't sign out, people get worried and will probably start a search for you.
