Ordinance O-2017-14

**AN ORDINANCE APPOINTING DUSTIN WADE AS A PART TIME POLICE DEPARTMENT
EMPLOYEE FOR AMELIA VILLAGE AND DECLARING AN EMERGENCY**

WHEREAS, The Mayor of Amelia Village after conferring with the Police Chief, has recommended the appointment of Dustin Wade as a part time police department employee for Amelia Village, and

WHEREAS, The Council of Amelia Village concurs in the appointment of Dustin Wade as a part time police department employee

NOW, THEREFORE, be it ordained by the Council of Amelia Village, Clermont County, Ohio, that;

SECTION I. Dustin Wade is hereby employed as a part time police department employee of Amelia Village, effective March 6, 2017 at a rate of \$8.25 per hour.

SECTION II. This appointment is contingent upon Mr. Wade passing pre-employment medical and/or psychological examinations and drug screening to ensure that Mr. Wade is physically and mentally able to perform the duties of a part time police employee, and must successfully pass any required OPOTA refresher courses within 90 days. Upon completion of the OPOTA refresher courses, Mr. Wade shall be sworn in as a part time police officer for Amelia Village.

SECTION III. Council hereby finds and determines that all formal actions relative to the passage of this ordinance were taken in an open meeting of this Council, and that all deliberations of this Council and of its committees, if any, which resulted in formal action, were taken in meetings open to the public, in full compliance with applicable legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION IV. That this Ordinance is hereby declared to be an emergency measure for the preservation of the public peace, health, safety and general welfare of the Village. The reason for such necessity is that the Police Department of Amelia Village has a vacancy that needs to be filled. Therefore, provided this emergency clause receives the affirmative vote of two-thirds of all members elected to Council, this ordinance shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise from and after the earliest period allowed by law.

Mr. Fite moved to suspend the rules requiring three readings on three separate dates.

Ms. Daniel seconded the motion.
