IN CONSIDERATION of being permitted to enter for any purpose any Restricted Areas (herein defined as including but not limited to the arena, competition area, chutes, pens, areas reserved and intended for participants or restricted to the general public, and all walkways, concessions and other areas appurtenant to any area where any NLBRA event shall take place), and/or being permitted to compete, officiate, observe, work for, or for any purpose participate in any way in any NLBRA event, EACH OF THE UNDERSIGNED, for themselves, their spouses, guests, children, agents, personal representatives, assigns, heirs, and next of kin, acknowledge, agree and represent that they have inspected, or will immediately upon entering any of such Restricted Areas and continuously thereafter inspect, such Restricted Areas and all portions thereof which they enter and with which they come in contact, and they do further warrant that their entry upon such Restricted Areas and their participation, if any, in the event constitutes an acknowledgment that they have inspected such Restricted Areas and that they find and accept the same as being safe and reasonably suited for the purposes of their use, and they further agree and warrant that if, at any time, they are in or about Restricted Areas and feel anything to be unsafe, they will immediately advise the officials of such and will leave the Restricted Areas.

- 2. EACH OF THE UNDERSIGNED HEREBY AGREES TO DEFEND, INDEMNIFY, AND SAVE AND HOLD HARMLESS the releasees and each of them from any and all loss, liability, damage, costs, claims, demands, actions or rights of actions they may incur due to the presence of the undersigned in or upon the Restricted Areas or in any way competing, officiating, observing, or working for, or for any purpose participating in the event and whether caused by the negligence of the releasees or otherwise; and
