IMPORTANT Members-Only Website Sign-up Information

To view any of the “members only” items, you MUST visit the NASCOE Members Only login/ registration page. There you must request a user- name and password (if you do not already have one). Upon doing this, you must submit the state you are a member of and any office position that you currently hold for you state Association. This will help expedite the verification process and gain you access faster!

Once you receive your username and password, you can access the website and be able to view the NASCOE, “MEMBER’s ONLY”, information .

Please Note: Passwords are not system generated; your membership must first be verified with your State Membership Chairperson. At times, this process has taken 2 weeks, or more, due to response time from states and your patience is appreciated. Once verified, an e-mail will be sent to you containing your password.

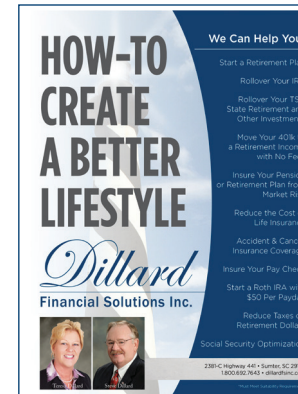

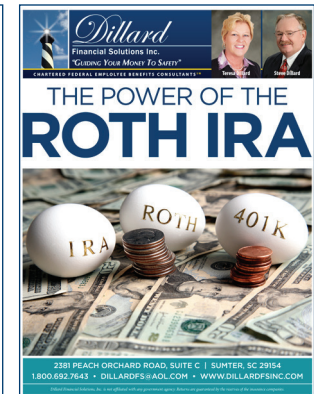

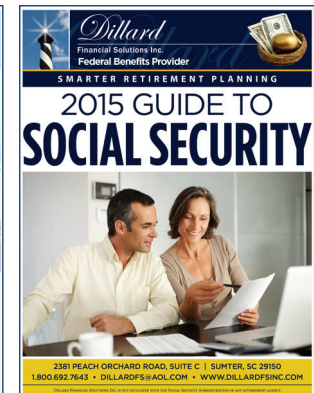
