With the start of 2015, we are looking for volunteers and forming the 2015 Hiddenbrook HOA committees. This is an excellent way to meet and get to know your neighbors as well as be "in the know" about current and upcoming events in the community. You are welcome to bring your background, experiences, knowledge, personal interests, etc. to our Association and join or lead a committee. The more committee members we have, the more we can accomplish and do for our residents with less work for everyone.

We currently have seven active committees: Architectural Review, Communications, Pool, Tennis, Social/ Recreation, Clubhouse, and Neighborhood Watch. One Board member is assigned as "liaison" to each committee for support. We encourage you to get involved with one or more of these committees and enjoy giving back to the community. You can spend as little time as your schedule allows on an ongoing basis or for specific events throughout the year. Every little bit helps and it can be very rewarding.

<u>Architectural Review Committee</u>: This committee reviews properties pre-sale in order to ensure there are no existing ARC violations, reviews and reports violations witnessed while traveling through the neighborhood, assists in reviewing ARC applications submitted to the Property Manager and assists with the annual property reviews. (2015 Scheduled for – April) Volunteers help improve our effectiveness and fairness in this process.

<u>Communications:</u> This committee maintains our website along with our Property Manager, compiles and publishes our monthly e-newsletter, posts events & activities to our Facebook account, sends out email notifications containing important neighborhood information and strives to provide helpful and positive support to our residents in a timely manner. Knowledge truly is powerful and good communication is vital for us all.

<u>Pool:</u> This committee communicates to our Property Manager and the Board, any pool repairs or issues that need to be addressed, suggestions for improving the pool area and operations and any member concerns or activities. This committee also ensures the shower and changing curtains are laundered and re-hung throughout the pool season and they maintain the lost and found area. This is an area of concentrated but very busy activities. The more help we have here the better we can make this operation run.

<u>Social/Recreation</u>: This committee coordinates events to bring our neighbors together. In the past, this committee has run the following events: Easter Egg Hunt, Fourth of July Parade, Dog Swim, and Halloween Trunk or Treating. Do you want to offer something for teenagers, a ladies night out, poker night, etc.? We are only limited in our offerings by the lack of volunteers or ideas. You can volunteer for one event or several.

<u>Maintenance/Clubhouse</u>: This committee works with the Property Manager to review our facilities and grounds to determine proper maintenance or repairs. We need volunteers to inspect the facility after rentals and take action as needed to ensure the facility is ready for the next renter. Volunteers are needed to help pick up trash around the facility and grounds, report items that need repaired, plant flowers/plants in the spring, water plants during the growing season, etc. The primary goal of this committee is to provide and maintain facilities that we can all use and be proud of.

<u>Tennis</u>: This committee communicates to our Property Manager any repairs or issues that need to be addressed and also makes suggestions for improving our tennis court operations and areas. We have done much to improve the conditions of this area and we need volunteers to help maintain the courts and equipment with occasional leaf blowing, sweeping, or a trash detail.

<u>Neighborhood Watch</u>: Volunteers are needed to report suspicious activity or security concerns through our Communications Committee to be disseminated to the community. Volunteers could also share information with the Board about concerns or areas that can improve our neighborhood safety.

Again, you can contribute as much or as little time as you have available on any committee you think you would enjoy. Currently, some of these committees only have one or two participants.

These lists may seem long and we know everyone is busy with daily schedules that are packed to the brim. That being said, what better investment can you make in your daily lives than to get to know your neighbors better, lend a helping hand which will most likely be returned to you when you need it, and have a renewed sense of satisfaction from contributing to the wellbeing of those closest around you.



Important Reminder!

There has been an increase in the storage of boats, trailers, motor homes and commercial vehicles within the community. This has resulted in multiple homeowner complaints and requests that action be taken to address this issue. We'd like to provide everyone with ample warning that a renewed enforcement effort related to this topic (as well as home maintenance and yard litter) will be taking place shortly. If you are currently parking any of these type items in your driveway or on your lot, we recommend that you start looking now for an alternative location to store/park them before our property reviews begin this spring. Many of the local storage facilities offer boat and camper parking.

The Hiddenbrook <u>ARC Guidelines</u> specifically state the following: 'Permanent or temporary (other than overnight) parking or storage of motor homes, mobile homes, trailers, boats, commercial vehicles, e.g. buses, taxi cabs, vans, or trucks with commercial logos and related equipment outside the garage or house of any owner is not permitted......These prohibited vehicles may be stored in an owner's garage, provided the door is regularly kept closed.

Fairfax County Code also limits parking of commercial vehicles, boats, trailers etc. on the streets within Hiddenbrook. Please visit

http://www.fairfaxcounty.gov/fcdot/parkingcodechanges.htm for more information on what is allowed to be parked on the Hiddenbrook streets.

We realize that as families grow and life in general causes us to accumulate more "stuff", the increase in so many more vehicles being parked in our neighborhood has increased safety risks and also changed the open feel of our streets and homes. No matter how unpleasant it may be, it is the responsibility of the ARC and the HOA Board to uphold and enforce the ARC Guidelines and Hiddenbrook Covenants. We strive to use good judgment in our assessments and actions and make decisions that are fair to all homeowners. We do not want to be so stringent that Hiddenbrook becomes an undesirable place to live, but sensible guidelines protect us all.

Copies of our covenants and ARC guidelines are available on our website and perhaps it would be helpful for you to review those documents to make sure you are in compliance. (Hiddenbrookhomes.org.)



Citizen Corps is FEMA's grassroots strategy to bring together government and community leaders to become involved in all-hazards emergency preparedness and resilience.


