

## At or Below 250% of the Federal Poverty Guidelines?

Check out the **NJ Comfort Partners Program**: Comprehensive home audit and energy-saving measures at **no cost to you**.

Program representatives will work with you personally, in your house or apartment, to evaluate the current level of energy efficiency in your home. They'll review many factors that affect your energy use – including home heating and cooling, water heating, lighting, and major appliances. They'll teach you and your family members new ways to conserve energy and help you create an action plan to support your efforts.

### Eligibility Requirements

The Comfort Partners Program is available to most New Jersey homes with significant energy use, and a household income at or below 250% of the Federal Poverty Guidelines as listed in the table below:

2022 Income Guidelines (250% of the Federal Poverty Guidelines)	
Family Size	Total Gross Income
1	\$33,975
2	\$45,775
3	\$57,575
4	\$69,375
5	\$81,175
6	\$92,975
7	\$104,775
8	\$116,575
For family units with more than 8 family members: Add \$11,800 to the total gross income for each additional member.	

Households that do not meet the above income guidelines but receive aid from other financial assistance programs may still be eligible.

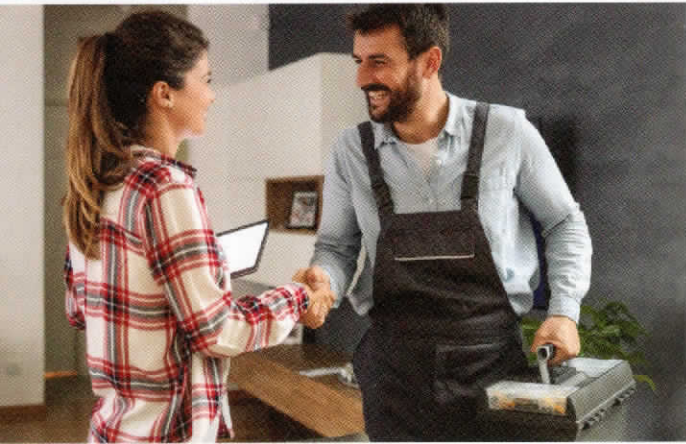
