I hereby petition for a Club Membership in Amelia Golf & Country Club, and agree, if elected to Membership, to conform and be bound by the Rules and Bylaws of the Club (as they now or hereafter exist) applicable to the membership for which I am herewith petitioning.

Initiation Fees – For such membership, I understand that at the time of this petition the initiation fee is \$_500.00_, and that I am required to purchase 2 share(s) of stock at the price of \$250 per share. If I am accepted for membership, any initiation fee must be received by the Club to activate membership. Purchase of stock may be made in installments. The first installment is due when membership is activated with the balance to be paid within six (6) months. No certificate(s) will issued until payment in full has been received by the Club. If membership is terminated either by the member or by the Club, stock must first be offered to the Club for purchase at the price paid by the member. If the Club does not purchase such stock, then the member may sell the stock as desired.

1. **Annual Dues** – Full dues for this membership are payable on January 1st each year. At the election of the member, dues may be paid quarterly, one-fourth due on the first day of January, April, July and October. In order to remain a member in good standing, dues must be received by the Club within thirty (30) days of the due date.
2. I specifically agree to be bound by the Rules and Bylaws of the Club in all matters pertaining to the membership herein petitioned for. I also recognize that circumstances may warrant the modification of or the amendment of the Rules and Bylaws and I will be bound to any changes as they may be from time to time.
3. If this petition is not approved by the Club, this agreement shall be cancelled. It is further understood and agreed that I may resign from the Club at any time by giving written notice to the Club 15 days prior to the effective resignation date and by paying dues or other charges for which I may be liable. Dues are non-refundable.
4. If elected to membership, I understand that payment is due as set forth above, at the date this petition is accepted, payable to the Amelia Golf & Country Club. A FINANCE CHARGE of 1.5% per month will be applied to all balances over thirty (30) days past due, which is an ANNUAL PERCENTAGE RATE of 18%.
5. The Club may terminate this membership for non-payment of any amount owed that is ninety (90) days past due. A photocopy of this contract shall be considered as valid as the original contract.
