The following 2020 monthly reports were received, reviewed and placed on file: April - I Cardenas, Co Sheriff, J Schildt, Clk of Dist Ct, K Brandt, Co Clk and L McCoy, Co Treas.

The April minutes of the Morrill/Scotts Bluff County Extension meeting were received, reviewed and placed on file.

Robin Stuart, Hospital Administrator, presented the April Financials to the Commissioners. Stuart said they had had no COVID-19 patients hospitalized, but had to keep 30% of the hospital beds available for them and ventilators. Stuart said the revenue had been down by 50% because of the Pandemic, but that the government money had helped.

Brad Slaughter from Piper/Sandler, met with the Board to discuss refinancing the Hospital Bonds at a lower rate and the possibility of refinancing the hospital's loan at the same time. Slaughter said it would save the county \$122,000 and the rate could be 1.790% over a ten year period. He said the Hospital wants to continue their payment the same and shorten the term. Slaughter said the final rate could be lower and the final date would be no later than July 7, 2020 for this transaction. Motion was made by Batterman, seconded by Sterkel, to call the original bonds and refinance the bonds at the lower rate and to adopt the following resolutions:

RESOLUTION #2020-15

A RESOLUTION OF THE COUNTY OF MORRILL, NEBRASKA TO AUTHORIZE THE EARLY REDEMPTION OF ITS GENERAL OBLIGATION HOSPITAL REFUNDING BOND, SERIES 2014.

BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF MORRILL COUNTY, NEBRASKA AS FOLLOWS:

Section 1. Morrill County, Nebraska (the "County") has previously issued its General Obligation Hospital Refunding Bonds, Series 2014, dated December 3, 2014 in the original aggregate principal amount of \$2,510,000 (the "Series 2014 Bonds"), of which \$1,750,000 in aggregate principal amount are presently outstanding. The Series 2014 Bonds were authorized by Article 35, Chapter 23, Reissue Revised Statutes of Nebraska, as amended (the "Act"), and a resolution (the "Series 2014 Resolution") duly passed and adopted by the County's Board of Commissioners (the "Board"). The County issued the Series 2014 Bonds to (a) advance refund a portion of its General Obligation Bonds, Series 2010, dated July 13, 2010, issued in the original aggregate principal amount of \$2,910,000 (the "Series 2010 Bonds"), and (b) pay the costs of issuing the Series 2014 Bonds. The County issued the Series 2010 Bonds too (a) finance the construction of an addition to, remodeling and renovations for and necessary equipment and furnishings for the County Hospital, and (b) pay the costs of issuing the Series 2010 Bonds.

Section 2. As set forth in the Series 2014 Resolution, the Series 2014 Bonds maturing on or after December 15, 2019 are subject to redemption at any time on or after December 3, 2019, as a whole or in part from time to time at the principal amount thereof, at a redemption price equal to the principal amount of the Series 2014 Bonds so redeemed, plus accrued interest on such principal amount being redeemed to the redemption date.

Section 3. Subject to the conditions set forth herein, the Board hereby authorizes the refunding and redemption of the following Series 2014 Bonds (the "**Refunded Bonds**"), and the payment of the redemption price of such bonds through and including July 7, 2020 (the "**Redemption Date**"), or such other date as shall be determined by the Chairperson of the Board, the County Clerk, the County Treasurer, the Chairperson of the Hospital Board or the Chief Executive Officer of the Hospital (each, including any person authorized to act on his or her behalf, an "**Authorized Officer**"), all in accordance with redemption provisions set for in the Series 2014 Resolution, after which date interest on such bonds shall cease:

Any Authorized Officer may determine that one or more maturities of the Refunded Bonds listed above shall not be refunded and redeemed on the Redemption Date. Such determinations shall be set forth in a certificate of such Authorized Officer.

Section 4. On the Redemption Date, the principal of the Refunded Bonds, together with all accrued interest to but not including the Redemption Date, shall be paid upon presentation and surrender thereof at the corporate trust office of BOKF, National Association, Lincoln, Nebraska, as paying agent and registrar for the Refunded Bonds (the "**Register**").

Section 5. In accordance with the Series 2014 Ordinance:

- (a) not later than 35 days prior to the Redemption Date (or such other date as may be acceptable to the Registrar), the Authorized Officers, or each individually, are hereby directed to file a copy of this Resolution with the Registrar: and
- (b) upon receipt of this Resolution, the Registrar is hereby instructed to mail notice of the redemption of the Refunded Bonds to each registered owner thereof not less than 30 days prior to the Redemption Date (or such shorter period as may be acceptable to the then registered owners of the Refunded Bonds); and
- (c) not later than 10 business days following its mailing of the redemption notice, the Registrar is further directed to file such redemption notice with the Municipal Securities Rulemaking Board and EMMA portal.

Section 6. This Resolution shall be in full force and take effect from and after its passage as provided by law. The refunding and redemption of the Refunded Bonds authorized by this Resolution are subject to the prior issuance by the County of its General Obligation Hospital Refunding Bonds, Series 2020 (the "**Refunding Bonds**"). The Resolution shall have no force and effect if the Refunding Bonds are not issued within one year of the date hereof.
