# **EXCITING NEWS**

Despite the current situation, our work continues. Since our last newsletter, William Huber, of Marion, Virginia, was hired by the Foundation to initiate the Historic Tax Credit Application process and architectural services. Bill's expertise of the application process, his knowledge of historic building systems, and his reputation for producing quality architectural services was of paramount importance and funded by your support and contributions

As of this mailing, Mr. Huber has produced and presented to the Foundation, Phase 1 and Phase 2 of the application documentation and architectural drawings detailing the home's current structural condition, selected demolition, and restoration are detailed below and will be available for you to view at the next fundraising dinner.

#### Phase 1

- Eliminate settlement of house interior by jacking load-bearing partitions and re-setting/replacing first floor beams and their supporting masonry piers.
- Repair roof structure and replace agricultural metal roofing with painted metal standing seam roofing; repair chimneys.
- Repair roof overhang, including associated trim, to eliminate bird intrusion.
- Replace 18' long two-story wall section of 8" CMU with salvaged historic face brick and wood frame backing.

#### Phase 2

- Restore/recreate exterior windows and doors, including shutters.
- Repair/re-point brick as needed.
- Restore interior finishes and trim, including door and window trim and fireplace mantels.
- Restore interior stairs.
- Restore brick hearths and provide central HVAC, with ductwork in crawlspace and attic.

We have received our first estimate of costs for restoration of the house. While this process continues to evolve, we will continue to seek cost estimates from additional sources for cross comparison.

Additionally, this estimate of cost will now allow the foundation to finalize our business plan and begin applying for grants. We hope to be included in the fall circuit of grant applications.

Phase three will be presented to the Board after this mailing. This phase will detail reconstruction of the front veranda and promenade deck and grounds planning. While landscaping is not covered under the Historic Tax Credits application, planning and development of the grounds will continue separately. Plans are underway to develop and recreate formal landscaping that was representative for estates andrefined homes of the time period. The plan includes native trees, boxwood, heir-loom plants and shrubs which were known to be used in such settings.

Little is known of the grounds surrounding the Octagon House. There is no known documentation of a garden layout or inventory of shrubs, trees, and other plantings. We do understand Dogwood and Red Bud trees were included in the landscaping and will be integrated as part of these restoration efforts.

Board members have continued to be active in attending to the grounds, directing the move of large shrubbery and ornamental shrubs on site, planting grass, and overall upkeep.

#### WHAT ARE THEY DOING

Many interested people often travel and visit the house throughout the year. Unfortunately, there is usually no one there to discuss the home's history and restoration plans. In order to expand our project footprint, visitors to the house will soon be able to have detailed information of its history, restoration plans, and future usage as a kiosk will soon be erected in front of the house. The front of the kiosk will detail Abijah and his family's history, the erection of the house, and its fall into neglect. The reverse side will feature the restoration plans and future usage.


