This course will be a review of dental fraud waste and abuse and investigation of common schemes, from a fraud investigator's perspective.

Synopsis: Health care fraud is a serious and costly problem that affects every patient and every taxpayer across our nation. Health care fraud occurs all across the healthcare industry that includes Medical, Pharmaceutical, Home Health Care, Durable Medical Products and Dental.

The vast majority of dental care providers are honest, law abiding and compassionate professionals. Antifraud statues and increased law enforcement efforts are focused to the fight fraud committed by those disreputable few people in the health care industry.

This unique presentation will identify what is and what is not fraud, common areas of fraudulent or

suspect activity and how suspect activities or schemes of fraud, waste and abuse within Dental are identified and investigated from a fraud investigator's perspectives.

- What makes up an investigation
- The impacts of Dental Fraud Waste and Abuse to our profession, patients and the health care system

About the Speaker: Stewart Balikov, DDS

Dr. Balikov is a 1983 graduate from the University of Southern California, School of Dentistry. He is currently serving as the Director of Dental Special Investigations, Oral Health Analytics for Anthem since October, 2017 having held the position of National Dental Director, Utilization Management for Aetna the prior 13 years. He is an Accredited HealthCare Fraud Investigator through the National Health Care Anti-Fraud Association, a Certified Dental Consultant through the American Association of Dental Consultants and a Certified Quality Assurance Consultant through the California Association of Dental Plans.

Dr Balikov is a frequent presenter at the National Health Care Anti-Fraud Association Annual Training Conference, and a course instructor at the Quality Assurance Certification Course for the California Association of Dental Plans. He is a member of the American Dental Association, California Dental Association, San Fernando Valley Dental Society, the National HealthCare Antifraud Association, Alpha Omega Dental Society and the American Association of Dental Consultants, of which he is a Past- President.

Dr Balikov currently holds licenses in California, Colorado and Arizona and maintains a limited practice in the Los Angeles, CA area.
