**AMANA CHURCH PRELUDE TO CHRISTMAS BAZAAR AND COOKIE WALK**

**During Amana's Prelude to Christmas**

Cookies, cookies and more cookies plus homemade holiday crafts – all for a good cause – will be at the Amana Church's annual Prelude to Christmas Bazaar, open two days, Friday, Dec. 2 and Sat. Dec. 3 and the Prelude to Christmas Cookie Walk on Saturday, Dec. 3, during Amana's Prelude to Christmas weekend.

Both are at the Amana Church in downtown Amana just ½ block west of Tannenbaum Forest at the Festhalle during our annual Advent celebration in Amana, Prelude to Christmas.

Here's how the Cookie Walk works: Come to the Amana Church, west entrance, starting at 9 a.m. Saturday to pick up your cookie walk reservation. Stay or come back at your appointed time. The Cookie Walk begins at 10 a.m. on Saturday, Dec. 3. Every 15 to 20 minutes we allow about 25 people to enter the cook walk room, wearing gloves, they select their cookies and candies from among all the cookies, bars and candies at the walk. Patrons purchase a cookie box for \$30. Boxes hold about 6 dozen cookies and candies. You fill your box with your selection from the thousands of cookies, candies and bars on display. The walk continues until all the sweets are gone.

The Amana Church Bazaar features homemade foods: yeast breads and kuchen, jams, jellies, salsa, fudge and caramel popcorn; plus handmade craft items, woodworking, needlework, toys, Christmas décor, ornaments for your tree and unique treasures. Nearly everything is made by local volunteers who donate their work to the Bazaar. The Bazaar is open Friday noon – 6 p.m. and Saturday 9 a.m. – 3 p.m. in the Amana Church in the village of Amana. Please use the west entrance. There is parking behind the church.

Proceeds from the Cookie Walk and Christmas Bazaar support the Amana Church's summer vacation Bible camp, the Sunday school and local youth groups. All are open to all youth. Your support is much appreciated.

Yes, we knew what was happening in our town thanks to this sheet of paper, the post office and the general store.

People might call it gossip, but there was a sincere caring for others.

I remember one lady who seemed to always go home and make a pot of chicken rice soup when she heard of the death in a family. When she died we all bemoaned her passing, but also remembered her kindness. To this day I can drive past her home and only recall her smile and the love she showed to others.

My mother also had to compose obituaries which were hard on her since she personally knew these people. The obituaries would not only be sent to the print shop in Middle, but to the "Pioneer Republican" in Marengo and the "Williamsburg Journal."

Someplace along the line she had been given instructions as to what and how to write these articles. She never got paid for any of this, including the times she served meals to the morticians over and over again. It was expected!

Years ago I indexed the first few decades of the "Bulletin."

One item I found amusing was written by the Homestead correspondent, Richard Seifert. He gave updates on a bull Homestead had.

I have no idea what breed it was although I am betting it was a white faced Hereford. Anyway after a period of time the bull whose name was "Bismarck," was transferred to Middle.

I guess Middle life was too strenuous on him because he died within a year and was mourned by the residents of Homestead.

This is the 90th year of the publication of the Bulletin. We, as a community, are still small and many care about one another

To me, at least, I can't think of a place I would rather live and be with such good friends.

  - b. 2022-115. Susan Matrise / 759 48th Ave Amana / HP-C / This is at the Blumen Haus Barrels and Blooms. 12' x 24' portable storage shed, painted wood sides in approved colors, with shingled roof - Hardy Lawn Furniture - Iowa City.

  - a. The subject of potential short-term rentals of residential properties (using the Airbnb and VRBO type systems) was first discussed at the October HPC meeting and then the November BOT meeting. It was confirmed that the ACLUD ordinances do not currently have definitions or guidelines regarding the short-term rental of residential property. Currently available rental definitions are: Bed and Breakfast, Boarding House, Hotel/Motel and Rooming House. Galena, IL, being a similar historic locale, might provide examples in their city code that could serve as a guideline for ACLUD. The Administrator was asked to talk to HPC and see if they will take on the task of researching and developing a draft ordinance.

Answer – you are directly supporting the infrastructure that helps insure the historical integrity of these Amana Colonies. If you start or even complete renovation projects on your residence or business without first getting a zoning permit, you are bypassing the step(s) that ultimately help to support your property values.

Just a reminder that included in the current Fee Schedule is the potential of an Upcharge Penalty (double fee) for projects that got either started or completed without first receiving a zoning permit. This can easily be avoided by simply contacting the ACLUD office (see below) when your project is in the planning stages.
