George White moved that the Board of Trustees sit as a Board of Canvassers for the purpose of canvassing the returns of the special bond election held in Moab, Utah, on August 14, 1979. Dan Holyoak Seconded. MOTION CARRIED.

The Board of Trustees thereupon made a proper canvass of the election returns of said special election and at its conclusion made the following official findings:

Dan Holyoak moved that the District pay the three election judges \$30.00 each and the three election counters \$15.00 each for their services at the bond election. Yvonne Colclasure Seconded. MOTION CARRIED.

Dave Bretzke stated that Grand County would advance another \$5,000 of the Phase II Sewer money on Tuesday, August 21st.

Dan Holyoak moved that the Spanish Valley District make available to Bob Norman and ** Hans Weibel 6,000 ft. of 6" plastic water pipe on condition that they make an application for a well, drill well, and do all of the labor of putting in the well and storage tank into Navajo Heights. Also conditioned upon Bob Norman and Hans Weibel deeding the system and well to the Spanish Valley District and furnishing the District with a lease on the tank site. District will then assume responsibility for the system. Proposals from both parties will be in written form. Yvonne Colclasure Seconded. MOTION CARRIED.
