Running Order and Class Information

Please check all your trial information carefully on the confirmation you were sent and notify me immediately in writing with any corrections. You can contact me via email at LKSAGE@aol.com or by phone (503) 840-4303 (cell).

SITE INFO: This trial will be held in two rings indoors on packed dirt. Crating is on concrete around the periphery of the rings. **You may set up your crating space Thursday afternoon beginning at 4 pm.**

DIRECTIONS TO THE TRIAL SITE:

From I-5: Take EXIT 9 (in Washington), head West on 179th Ave. for ½ mile, turn left onto 2nd Ave., then turn left again at Gate 7. Exposition and Equestrian Bldg. is on the right, at the end of the road. Feel free to park in any marked parking spot around the arena building. Please do not block any arena entrance or access road.

MEASURING: We will have a VMO on site so all dogs without height cards will have to be measured, including the 24 & 24C" dogs. Handlers whose dogs need to be measured will not be able to get their armbands until they are measured. We will have a VMO available to measure dogs throughout the day near the trial secretary's table. It is your responsibility to have your dog measured BEFORE you run.

GENERAL: ALL dogs are required to be kept on leash at ALL times. And please pick up after your dogs.

WALK THROUGH BREAKDOWN: We are going to set the walk throughs for the **Exc/Master Standard and JWW** classes as follows: Small to Tall days, Walk 4-12, Walk 16, Run 4-16. Walk 20, Walk 24, Run 20-24. Tall to Small day, Walk 24, Walk 20, Run 24-20. Walk 16, Walk 12-4, Run 16-4.

FAST WALK THROUGH, We will Walk Exc/Master, then walk Open and Novice together, then Run Exc/Master, Open and Novice.

CONFLICTS: We will do our best to accommodate conflicts. If you have a conflict, Standard takes precedence over FAST and JWW. Put a "C" instead of a check mark on both gate sheets so the scribe and gate stewards will know you have a conflict.

MOVE-UPS: The deadline for move-ups is Monday, Jan 1, 2018 at 6 pm and must be submitted in writing (email ok). Day-to-Day move-ups will be permitted at these trials and must be submitted to the score table no later than 30 minutes after the end of the trial.

FOOD: Sweet AI's will be the food vendor on site and will be open from 8:00 am to the end of the trial each day.

So again, please come and remind us or send someone to remind us and we'll be ready with a ribbon.
