## Clock is ticking on AG Covenant & Bylaw Restatement Vote

Voting and approval on the covenant and bylaw restatements are continuing and approximately 1/3 of the total potential ballots and approval forms have been received (i.e. the Association has received about 33 out of 99 potential ballots

back). In order for the restated covenants and by-laws to be approved the Association will need to receive at least 67 ballots/approval forms back with an affirmative vote. If you are reading this Gazette, there is a strong likelihood that you've already sent yours back, but if not, please do so as soon as possible. Also, it wouldn't hurt to call your neighbors or knock on their door when you get an opportunity to make sure they've done the same. We've still got a few months (until June 10, 2011), but the clock is ticking and the sooner they are returned the better. One of the most important things that we continually stress is that these restated covenants and bylaws fully preserve the integrity and high-quality nature of Andover Glen. They are generally neither more restrictive nor less restrictive than the original covenants, but they add a great deal of clarity and clean up some of the unclear and outdated language. Please contact any board member if you have any questions and we will keep you up to date on the status of the voting progress here in the Gazette. ~

Spring is a time for being outdoors. It is also when we leave garage doors and household doors open. Nearly 40% of the thefts and burglaries in Aurora take place because

house and car doors are left open or unlocked and valuables are left in plain sight. These are crimes of opportunity.

# Help the Aurora Police Department keep our neighborhood safe by following these tips:

- Keep your garage door closed...especially at night.
- Remove all valuables & lock your car when parked in your driveway or garage.
- Call your neighbor if you think they forgot to close their doors.
- Make sure bicycles are not left outside or unattended.
- Use exterior lighting at night around your house
- Report suspicious people or vehicles in your neighborhood

What is suspicious activity? When do I call the police? There are a variety of signs or indications that give way to a crime about to be, in the course of and in the aftermath of

committal; the important thing is not to attempt to investigate strange occurrences and for that matter to try and apprehend a suspect by yourself. Your Neighborhood Watch Area Coordinator can provide information to educate you about suspicious activities of all sorts and assist in keeping you, your home and neighborhood safe.

Recent protection strategies implemented in the past year have helped improve safety and awareness in our neighborhood. With the addition of a "No Solicit" campaign coupled with increased resident involvement in the "Email Alert System", incidents of vehicle and home vandalism or theft can be and have been mitigated. Foot traffic such as paper flyer delivery, door to door meat or seafood sales as well as latter aged teens selling anything for their benefit are violations of our no solicitation mandate and these are prime candidates of suspicion to be reported to Aurora dispatch.

#### Some Tips to Survive the Snowiest Month (without getting a fine from the city)

**M** any people don't realize that March is the Metro Area's snowiest month, and they also may not realize that they need keep their walks clear of snow. Snow and ice on sidewalks can be slippery and dangerous, not only to mail carriers and other delivery people but also to senior citizens, children, disabled people and the public in general.

As a resident or property owner, it is your responsibility to keep those city sidewalks adjacent to your property free and clear of snow and ice, even though the sidewalks may be behind or outside the rear and side fences and adjacent to any street.



Snow and ice must be removed within 24 hours after a snowfall ends, and 48 hours after a snow emergency is declared by the city. To ensure pedestrian safety, City of Aurora Code Enforcement Officers respond to citizen complaints concerning lack of snow and ice removal from sidewalks. Failure to comply with the ordinance carries an Administrative Charge. Charges not paid within 10 days will result in a Summons being issued to Aurora Municipal Court. Officers are not required to give a warning notice prior to issuing a snow ticket.
