The meeting was called to order at 7:06 P.M.

- There were 8 homeowners families and 5 board members at the meeting. This was a quorum of homeowners.

6) Homeowners Items of Concern, Suggestion or Comments:

- a) The Claremont Connector Hike and Bike Trail Project was discussed along with Floyd Road Bike and Hike Trail.
- b) The replacement of the wood monument board with a stone monument was discussed along with replacing the current lights with new LED lights.
- c) There was a review of work going on in the electric easement. The board has a contact phone number of the project manager. He stated that the easement will be restored to it state before any work began.
- d) The board has received a request from a pipeline survey company to place an underground pipeline. More information needs to be provided about the pipeline.
- e) A homeowner asked about getting flags for the holiday. This placement is handle by Troop 615.
- f) Jack met with the city regarding our uneven or broken sidewalks and pinpointed about 15 places where repair is needed. After going over the damaged areas, they agreed to rehabilitate the identified spots. They are:
 - a) 504; 502; 415; 412; 314; 106-108 Clear Creek Meadows drive.
 - b) 311; 303; 204; mailbox shelter on Meadow gate Drive.
 - c) 509: 513; 515 Cedar Prairie Drive.
 - d) Some homeowners suggested other location that need repair. The city will be contacted.
 - e) There also is sidewalk damage at a storm sewer cover in the common area by the high lines but the city isn't going to address that because it is next to the area that Centerpoint Energy will be repairing after the new lines are installed. Their thought is that Centerpoint will probably fix that spot. However, if that doesn't happen, I got an commitment from the city that they would return and take care of it.
- g) All of the 13 pink fire hydrants have been painted. Some of the hydrants are missing the identifying reflector that should be in the middle of the street directly adjacent to the fireplug so that firefighters can spot them when cars are parked on the roadside. Public Works will be made aware of the need to install them.
